##### **Processing purposes and legal basis.**

In accordance with Article 6 of the Regulation, processing is necessary for the performance of a task carried out in the public interest or in the exercise of official authority vested in the controller. Processing of the data given is performed for admission procedures purposes and for carrying out the Professional Master Course.

In particular, the data given will be collected and processed for carrying out the purposes below:

- establishment of the existence of the requirements needed for the selection procedure;

##### **Nature of personal data conferral and consequence of a possible refusal**

Personal data processing is carried out in accordance with the principles of lawfulness, fairness and transparency, also with computerized and online tools for the storage and management of the data and, and in any case, with methods that guarantee the protection of the data subject's privacy.

Conferral of personal data is obligatory. Failure to obtain the data makes the processing of personal data for admission procedure purposes impossible for the data processing controller, the data protection Officer and the other delegates and therefore invalidates the possibility to take part in the selection procedure and to carry out the procedures connected to it.

##### **Processing methods and processing authorised persons**

The principles of relevance, comprehensiveness and the principle of proportionality for processing purposes with regard to personal data apply to the data collection.

The processing of the aforementioned data is carried out with various procedures and the data is collected in physical and computerized archives exclusively for carrying out the legal requirements or for educational and administrative purposes.

##### **Data subject rights**

Data subjects have the right to obtain from the data controller or the data processor, where the conditions for it are met, the access to personal data in accordance with Article 15 of the Regulation, the rectification of said data in accordance with Article 16 of the Regulation, the erasure of the personal data concerning them in accordance with Article 17 of the Regulation or the limitation to personal data processing in accordance with Article 18 of the Regulation, or they may object to personal data processing in accordance with Article 21 of the Regulation, beyond having the right to data portability in accordance with Article 20 of the Regulation.
