Art. 1 – Course activation

Selection for the admission to the *Summer School* "ManGrowth – Preservation of Ecosystems for Sustainable Development", activated for the academic year **2025/2026**, is announced. The main characteristics are described in the Training Plan published on the page dedicated to this course <u>Summer School in ManGrowth – Preservation of Ecosystems for Sustainable Development | Sapienza Università di Roma</u>

This course involves the acquisition of 10 CFU.

Art. 2 - ADMISSION REQUIREMENTS

A 1st Level Degree is required to access the course in the areas of biology, ecology, environmental science, veterinary science, forestry engineering or related subjects.

Art. 3 - COMPLETING THE PRE-ENROLLMENT APPLICATION

To participate in the admission competition, the candidate must, under penalty of exclusion, perform the following instructions:

a) Register on-line with the Sapienza (Infostud)

You can register at the page <u>https://www.studenti.uniroma1.it/phoenixreg/#/</u> and obtain a registration number and a password to access the system.

It is also necessary to enter the university degrees on your Infostud profile, which is useful for admission to the Course (after accessing Infostud, click on "Profile" and then on "University degrees"). The registration number must be inserted in the application for admission to the Course.

Please note: Any communications will be sent exclusively to the e-mail address indicated at the time of registration on Infostud. Candidates are recommended to check the accuracy of the mailing address entered.

Students already registered on the Infostud system must check / enter their email address using the User data > edit access data function.

b) APPLICATION FOR THE ADMISSION:

Fill in the application form in Attachment 1, including registration number, readable signature and copy of a valid <u>Passport</u> and of a <u>degree certificate</u>. Application from non-mozambican candidates not accompanied by a passport valid for six months after the Summer School will not be considered.



Attach curriculum vitae.

Attach motivation letter in English. Such letter must contain information about previous educational and work experience in the field of plant and animal ecology and the motivations which lead the candidate to apply for the Summer School in Mangrowth - Preservation of Ecosystems for Sustainable Development. Submitting also a short video in English is strongly encouraged, as it may enhance the candidate's chances of selection.

For candidates with qualifications obtained abroad submit (<u>if required</u>) one of the following documents:

- Declaration of Value issued by the Italian consular authority of the country of study (with transcript of records + copy of the final diploma) or
- CIMEA Certificate of Comparability accompanied by CIMEA Verification Certificate (by accessing the CIMEA platform: http://www.cimea.it/it/servizi/attestati-di-comparabilita-ecertificazione-dei-titoli/attestati-di-comparabilita -and-verification-of-qualifications-diplome.aspx) or
- Diploma Supplement (in the case of a European qualification) issued by the University of origin and legalized at the Italian Embassy in the country of study.

Non-EU citizens residing abroad must comply with the inter-ministerial provisions contained in the circular "Procedures for the entry, stay and registration of foreign / international students to higher education courses in Italy academic year 2025-2026, available at the link: https://www.studiare-initalia.it/studentistranieri/".

Candidates with recognition of disability pursuant to art. 3, paragraphs 1 and 3, of law no. 104 of 1992 and / or with a disability equal to or greater than 66%, need to attach:

copy of the certificate of disability issued by law, under penalty of exclusion from the benefits provided. Applications with incomplete documentation, submitted in ways other than those envisaged or submitted after the deadline, will not be accepted.

c) SENDING THE ADMISSION APPLICATION:

The candidate must send the admission application accompanied by the required documents within JULY 07, 2025, 00:00 (midnight) GMT+2, to the e-mail address: mangrowthcourse.dba@uniroma1.it

Art. 4 - LIST OF ADMITTED

The course secretariat verifies the admission requirements. <u>Successful applications will be</u> <u>assessed by the Course organizers</u> who will consider the relevance of the candidate's educational background, previous work and research experience, and proficiency in English. <u>The organizers</u> <u>reserve the faculty to conduct follow-up interviews</u>, if necessary, by appointment arranged with the candidates. A preliminary list of participants in the *Summer School* will be published **by July 11**, **2025**.

Following the publication of those admitted, and the confirmation of participation in the course to be communicated by **July 14, 2024**, by e-mail, it will be possible to enroll in the Course by paying the enrollment fee according to the procedures indicated in Article 6 of this notice.

Art. 5 - REGISTRATION FEE

Participation in the course requires an amount of €. 50.00 plus stamp duty of € 16.00 to be paid in accordance with the terms of art. 6 no later than July 31, 2025. <u>Grants and facilities for the enrollment</u>



fee will be directly communicated by the course secretariat to the admitted participants.

This summer school takes place within the framework of the "ManGrowth - Preservation of Ecosystems for Sustainable Development", funded by the Italian Agency for Development Cooperation. The Summer School "Mangrowth - Preservation of Ecosystems for Sustainable Development" is also supported by the Department of Environmental Biology of Sapienza – University of Rome.

Travel costs to reach the course locations (Eduardo Mondlane University in Maputo; Inhaca Island Marine Biology Station), food and accommodation will be covered by the project "ManGrowth - Preservation of Ecosystems for Sustainable Development" with the support of the Italian Agency for Development Cooperation.

Students with a recognized disability equal to or greater than 66% or with a recognized disability pursuant to Article 3, paragraphs 1 and 3 of Law no. 104 of 5 February 1992 are exempt from 50% of the registration fee. To take advantage of the reduction, students must send documentation proving their disability to <u>sportellodisabili@uniroma1.it</u> and for information to <u>altaformazione@uniroma1.it</u>.

The registration fee can be refunded only and exclusively in the event that the course is not activated.

Art. 6 - PAYMENT METHOD OF THE REGISTRATION FEE

The student admitted to the course must access Infostud2.0 from the page https://www.uniroma1.it/en/pagina-strutturale/students with registration number and password, click on the box "TRAINING COURSES", then click on "TAXES -Enrollment ", enter the course code indicated in this notice and follow the subsequent instructions. Payment of the registration fee must be made within the deadline as per art. 5 of this notice, through the bulletin downloaded from Infostud as described on the web page of Sapienza institutional site: https://www.uniroma1.it/en/pagina/payment

Teacher's Card: Permanent teachers of educational institutions of all levels can pay up to € 500.00 through the use of the so-called "Teacher's Card".

In this case, after the deadline indicated in art. 2, the participant admitted to the course must write to the email address <u>altaformazione@uniroma1.it</u> attaching the bonus generated by the MIUR site to receive, again by e-mail, a bulletin to pay the difference, if due, between the enrollment in the course and the amount of the bonus.

Financing by a company: To finance the enrollment of one person or more people in a course, the beneficiaries of the financing must register on Infostud and obtain the bulletin (point 5), and then perform the following steps: send an email to <u>altaformazione@uniroma1.it</u>

Art. 7 - DURATION AND ORGANIZATION OF TRAINING ACTIVITIES

Course Duration

The course lasts 4 weeks.

Course activities will begin on **October 8, 2025**, and will end on **November 6, 2025**, as outlined in the Teaching Program published on the dedicated page of this Summer School <u>Summer School in ManGrowth</u> – <u>Preservation of Ecosystems for Sustainable Development | Sapienza Università di Roma</u>. The educational program involves a total commitment of 190 hours, consisting of lectures, laboratory sessions, practical exercises, personalized training, and field activities. The ManGrowth – Preservation of Ecosystems for Sustainable Development School is designed as an <u>intensive course and includes fieldwork</u>.

The course is organized into thematic modules. Each module includes both classroom sessions and hands-on activities for all students. A project assignment is planned for each module. The development of these projects will be carried out in groups. Each group, led by its designated instructor, <u>is required to submit a final project report</u>.

Travel and Logistics

With the support of the Italian Agency for Development Cooperation (AICS), the ManGrowth <u>Project will</u> <u>cover travel and accommodation expenses exclusively for participants who are not residents of Maputo</u>. Admitted participants will receive information on visa application procedures for entering Mozambique. No-mozambican participants must check their vaccination status by following the guidelines provided on the Ministry of Foreign Affairs website: <u>https://www.viaggiaresicuri.it/find-country/MOZ</u>.

Please report any food allergies. Given the remote location of the course venue, <u>alternative dietary options</u> <u>cannot be guaranteed unless for medical reasons</u>. Therefore, kindly notify us in advance of any <u>dietary or</u> <u>health needs</u> so that suitable arrangements can be made.

Venue

The course will take place on Inhaca Island, located at the entrance to Maputo Bay, approximately 32 km from the city, within the Ponta do Ouro Partial Marine Reserve.

The course will be based at the Inhaca Island Marine Biology Station (EBMI), a research center belonging to Eduardo Mondlane University. The station includes laboratories, a library, a museum, dormitories, and a kitchen.

Due to the remote location and logistical constraints, meals will be the same for all course participants and will be nutritionally balanced, including sources of animal protein, vegetable fiber, and carbohydrates. Access to medical care in the area may be limited; therefore, participants are advised to take the necessary health precautions before departure, in line with general recommendations for travel to tropical countries and remote areas.

Course Philosophy

The Summer School is designed to be dynamic, based on an active learning approach that requires <u>immersive and continuous engagement</u> throughout the course duration.

The course requires a high level of commitment and physical endurance. Activities will take place under demanding conditions, including exposure to intense heat, difficult terrain, and several hours of fieldwork.



- Morning: Thematic project work (field activities and data collection) starting at 08:00 (or earlier, depending on the instructor's needs) until around 12:00
- Afternoon: Lunch followed by data collection/analysis, lectures, field activities, and report writing from around 14:00
- Evening: Dinner followed by lectures, project work, writing, and presentation preparation

Expected Outcomes by the End of Each Thematic Week

• Presentation of a <u>preliminary report for each project</u> (in scientific article format—refer to the <u>Proceedings of the First Summer School</u>), delivered through a 15-minute oral and visual presentation, followed by a Q&A session

Expected Outcomes by the End of the Summer School

A booklet will be produced to publish the results and will include:

- Mini-biographies
- Project reports
- Activity report

Note: Lectures and presentations may be recorded and uploaded to YouTube, including the logos of AICS, Eduardo Mondlane, Sapienza, and, if applicable, your home institution.

Attendance of 75% (or other higher percentage decided by the Director) of the Course activities entitles you to a certificate of attendance and allows for the eventual recognition of CFU as follows:

1. CFU acquired in the Advanced Training Courses are recognizable, according to the regulations in force, in a first or second level degree course (up to a maximum of 12 CFU) and in a first or second level master course.

2. CFU acquired in training courses or in intensive courses (Summer / Winter School) can be recognized according to the regulations in force in first level degree courses up to a maximum of 12 CFU.

In the event of non-attendance, or other behavior that is however reprehensible, the Director may decide not to issue the certificate of attendance of the Course.

Legal basis and purpose of the processing.
