**Art. 1 - INSTITUTION**

Sapienza University of Rome announces the call for applications to the 18<sup>th</sup> cycle of the European PhD program in *Socio-Economic and Statistical Studies* (hereinafter Sess.EuroPhD). Sess.EuroPhD is an international, interdisciplinary graduate programme in the areas of Economics, Statistics and Economic Sociology. The program lasts three years, and it is currently co-ordinated by the “Eötvös Loránd” University of Budapest. Below is a brief description of the program.

All applicants must submit the following material: 1. A copy of an updated CV/résumé;

2. Certification of further qualifications, such as a Master degree and any other post-graduate course, with transcripts of courses attended and grades received;
3. A Statement of Purpose concerning your plans for PhD studies and your career objectives (no more than 1500 words);
4. Two confidential letters of recommendation (**to be sent directly by the recommenders** by **July 13, 2018** to the following e-mail address: [sess@uniroma1.it](mailto:sess@uniroma1.it));
5. Copies of publications the candidate wishes to submit to the admission committee (no more than 3 published papers/books/reports with ISSN or ISBN);
6. A Research Project in which the candidate concisely spells out the research agenda for his PhD studies (no more than 5.000 words).
7. A list of publications the candidate wishes to submit to the Admission Committee (no more than 3 published papers/books/reports with ISSN or ISBN)
8. Statement under the candidate own responsibility of the veracity of the documents submitted.

## Art. 2 – REQUIREMENTS

Applications are accepted from candidates, regardless of gender, age and nationality, who hold an Italian *laurea specialistica*, *laurea magistrale* or an equivalent second-level degree (generally equivalent to a Masters Degree) obtained abroad or who expect to receive their degree by **October 31, 2018**.

The Coordinator of each programme will ascertain the equivalence of each academic title obtained abroad to the relevant Italian degree for the sole purpose of this call, or in the frame of inter-university cooperation and mobility agreements.

Applications are also accepted from candidates who expect to receive their degree by **October 31, 2018**.

Admission is conditional to reception of relevant degrees by the indicated deadlines.

Students currently enrolled without a fellowship can participate to competitive exams for the same PhD programme they are already attending, but, if admitted, they cannot enrol unless they formally resign their doctoral position with the relevant academic board.

## Art. 3 - APPLICATIONS

The application procedure consists of the following steps:

1. Fill and sign the **application form** attached at the end of this call (check at the end of this document);
2. Prepare a Zip compressed files containing all the required documents listed in Art. 1 (Please name the Zip file this way “SESSapplication\_SURNAME\_NAME.zip”).
3. In order to submit an application, candidates must pay a **€ 35** non-refundable application fee at any branch of the “UNICREDIT” Bank by **July 13, 2018** using the payment form that is available at <https://www.uniroma1.it/it/pagina/dottorati-presentazione-della-domanda>.
4. Please note that the copy of the application form, along with a PDF copy of all files and documents, and a copy of the bank payment must be included in the Zip file named “SESSapplication\_SURNAME\_NAME.zip” and must be sent, by 13/07/2018, to [sess@uniroma1.it](mailto:sess@uniroma1.it).

**Applications not accompanied by the proof of payment of the application fee will NOT be considered.**

The signed copy of the application form have the same validity as an official self-declaration as established by Bill N. 445/200.

#### **Art. 4 - APPLICATIONS BY CANDIDATES WITH A FOREIGN ACADEMIC DEGREE**

In order to submit an application, as indicated in the preceding article, candidates with a foreign academic degree must:

1. Pay the non-refundable **€ 35** application fee as indicated in article 3;
2. Submit the following documentation by **July 13, 2018**:

**Candidates with an EU academic degree:**

- Self-declaration affidavit with signature (dichiarazione sostitutiva di certificazione e/o dell'atto di notorietà according to art. 46 and art. 47 of D.P.R. 445/2000) of academic degree with a full list of exams and grades, in Italian or English.

**Candidates with a non-EU academic degree:**

- A legalized translation of the academic degree into English or Italian with a full list of all exams and grades obtained;

**Applications lacking any of these documents will be rejected.**

The documents listed above must be submitted to the University PhD Office by **July 13, 2018** by email with object "**DOCUMENTAZIONE PER IL CONCORSO DI DOTTORATO - CODICE [insert PhD Code]**" to the address: **sess@uniroma1.it**

**Please note that applications not submitted as described herein will be rejected.**

Candidates who are admitted will be asked to present

1. A legalized translation of the academic degree into English or Italian with a full list of all exams and grades obtained
2. The Declaration of validity ("dichiarazione di valore") issued by the competent Italian consulate or embassy in the country where the academic degree was attained or the "Diploma Supplement"
3. Candidates admitted without fellowship must prove to have adequate funds to sustain him /herself for one year (at least € 5.000) or, alternatively, that has a scholarship for the entire duration of the PhD programme.

#### **Art. 5 - APPLICATIONS BY FOREIGN CANDIDATES AS SUPERNUMERARY STUDENTS**

Foreign candidates who do not plan or need to request a fellowship may apply for a PhD position, not covered by a grant, as a supernumerary student (*ammissione in soprannumero*).

Up to one third of the positions assigned to each PhD Programme are reserved to supernumerary students, who are not required to participate in the admission examinations. They will be evaluated on their curriculum, academic qualifications and through an interview.

In this case, applicants must:

1. Clearly indicate in their application - submitted as per Art. 3 - that they are applying for a position as supernumerary student.
2. Pay the **€ 35** non-refundable application fee (as indicated in Art. 3).
3. Provide the following documents by **July 13, 2018**:

**Candidates with an EU academic degree:**

- Self-declaration of academic degree with a full list of exams and grades, in Italian or English.

**Candidates with a non-EU academic degree:**

- A legalized translation of the academic degree into English or Italian with a full list of all exams and grades obtained.

The documents listed above must be submitted to the University PhD Office by **July 13, 2018** by email with object "**DOCUMENTAZIONE PER IL CONCORSO DI DOTTORATO - CODICE [insert PhD Code]**" to the address: **sess@uniroma1.it** together with copy of the candidate's ID/Passport.

**Applications lacking any of these documents will be rejected.**

Candidates who are admitted will be asked to present before to sign in:

- The legalized translation of the academic degree into English or Italian with a full list of all exams and grades obtained;
- A Declaration of Validity (“dichiarazione di valore”) issued by the competent Italian consulate or embassy in the country where the academic degree was attained or the “Diploma Supplement
- Documents providing evidence that the applicant has adequate funds to sustain him /herself for at least one year (at least € 5.000) or, alternatively, that the applicant has obtained another scholarship for the entire duration of the PhD programme

Applications as supernumerary students will be evaluated by the Coordinator that will consult the Academic Board and decide if the application will be accepted. If the candidate doesn't have notice that the application has been rejected, must participate directly to the oral examination.

Foreign students applying for admission as supernumerary and cannot attend the oral examination at Sapienza may ask to be evaluate on a dossier. In this case the must ask it to the coordinator of the PhD programme they want to follow and send her/him a coherent research project written in Italian, English or French together with all the other documents that can demonstrate of their academic/scientific qualification.

**Please note that applications not submitted as described herein will be rejected**

## **Art. 6 – APPLICATIONS BY RESEARCH GRANT HOLDERS AND PUBLIC EMPLOYEES**

Applicants holding a research grant (*assegno di ricerca*) and public employees can apply to be admitted to PhD programmes as supernumerary students **if they pass the admission tests**.

These candidates have the right to up to 1/3 of the positions assigned to each PhD programme.

To apply as supernumerary students, candidates must specify that they are public employees or research grants holders in their application by putting a mark in the relevant boxes. Applications must be submitted as described in Art. 3. Research grants holders must also provide full details on their research grant.

Research grants assigned after the submission of a PhD application must be immediately communicated to the PhD Office by means of a written note (delivered by hand or sent by e-mail).

## **Art. 7 – DISABILITY ASSISTANCE**

**Students with a disability equal or higher to 66%**, who require assistance or have special needs (i.e., tutorial assistance for reading and/or writing, special assistance, Sign Language interpreter, 30% extra time over regular exam times, etc.) should contact the Sapienza Office for Students with Disabilities at the toll-free number 800.410.960 or by e-mail to [sportellodisabili@uniroma1.it](mailto:sportellodisabili@uniroma1.it). A calculator and a PC with voice synthesizer system and software for magnifying text and images is always available.

Candidates will be allowed to a 30% extra time. A calculator is also available depending on the specific need indicated on the certificate.

The Learning Disabilities certificate must explain the kind of disability (Reading and/or Writing and/or Calculation) Application for disability assistance must be submitted to the Office for Students with Disabilities by **July 13, 2018** together with the medical certification issued no more than 3 years before by an authorized official structure.

## **Art. 8 – ADMISSION TESTS**

The application evaluation process for the Sess.EruoPhD program consists of: 1) A review of the Candidate's CV and documents; 2) A review of the letter of intent and research project; 3) An interview

**The doctoral admissions committee reviews applications for admissions electronically. Consequently, all documents must be in PDF form and must be sent by E-mail to [sess@uniroma1.it](mailto:sess@uniroma1.it). Do not send any hard-copy of transcripts or materials.**

**Please note: a) Candidates wishing to participate in this PhD call must be present at the date, time and location indicated on this call, the Italian version of the call or the website without any further notice; b) Candidates must provide a valid ID to be admitted to the interview; c) Skype-conference are allowed under request.**

## **Art. 9 – EXAMINATION BOARDS**

All Admission Committees assessing admission to the all PhD programmes are nominated as established by Art. 9 of the Sapienza PhD Regulations (see <http://www.uniroma1.it/didattica/offerta-formativa/dottorati>).

Sess.EuroPhD Admission Committee will be consisting of three Professors nominated by The Faculty Board of the Doctorate. Each candidate is evaluated on a maximum of **120 points**. The minimum mark to enter the final ranking is **95 points**. The maximum mark will be distributed according to the following criteria:

- Up to **80 points** for the CV, background studies, publications and past research experience.
- UP to **40 points** for the interview

At the end of the admission exams, the Admission Committee will publish a general ranking of candidates based on the sum of all the scores achieved by each candidate. In case of equally ranked candidates, the following criteria will be adopted:

- In case of identical ranking for the assignment of a research fellowship, preference will be granted to the candidate with less income;
- In case of identical ranking for positions without a scholarship, preference will be given to candidates who:
  1. Have academic degrees with the highest grades;
  2. In case of identical academic grades, preference will be given to the candidate with the highest average of exams grades;
  3. In case of identical exam grade average, preference will be given to the candidate who earned his/her academic degree in the shortest time period;

In case points (1), (2) and (3) are identical, preference will be given to the youngest candidate. The Examination Boards that will assess admission to the PhD programmes are nominated as established by Art. 9 of the Sapienza PhD Regulations (see <https://www.uniroma1.it/it/pagina/dottorati-di-ricerca;>).

A single Examination Board will test candidates applying to multi-disciplinary PhD programmes. However, candidates will be requested to make their choice during the written test or in the way indicated on Course website. At the end of the admission exams, the examination Board will publish a general ranking of candidates based on the sum of the two exam scores achieved by each candidate. In case of equally ranked candidates, the following criteria will be adopted:

- In case of identical ranking for the assignment of a research fellowship, preference will be granted to the candidate with less income;
- In case of identical ranking for positions without a scholarship, preference will be given to candidates who:
  1. Have academic degrees with the highest grades;
  2. In case of identical academic grades, preference will be given to the candidate with the highest average of exams grades;
  3. In case of identical exam grade average, preference will be given to the candidate who earned his/her academic degree in the shortest period;
  4. In case points (1), (2) and (3) are identical, preference will be given to the youngest candidate.

## **Art. 10 – ADMISSION TO PhD PROGRAMMES**

Applicants will be admitted to PhD programmes on the base of the final ranking (winner list) until all available positions have been assigned. If a candidate does not reply to his admission invitation or accepts late, the following eligible candidate will be offered the position. A candidate admitted contemporarily to two or more PhD programmes, must choose only one to attend.

Candidates who already have a PhD diploma can be admitted, after having passed the examinations, to another PhD programme, only if the scientific sectors of the two programmes are different.

**Students cannot be awarded the doctoral fellowship twice.**

#### **Art.11 – ENROLLMENT IN PhD PROGRAMMES**

Once admission procedures have ended and have been approved, the candidate ranking will be published on the Sapienza website at <https://www.uniroma1.it/it/pagina/dottorati-di-ricerca>:

**The ranking will include enrolment schedule and procedures.**

**Successful candidates who do not respect these procedures will lose the right to their place, which will be offered to the next-ranked candidate.**

When the final candidate ranking is published, an e-mail will also be sent to each candidate to the address indicated on the application form.

**When the final ranking is published, candidates admitted that are temporarily not able to register as expecting to receive their degree by October 31, 2018, must send an email to [ufficio.dottorato@uniroma1.it](mailto:ufficio.dottorato@uniroma1.it) with their commitment to matriculate as soon as the degree will be received. The email must have attached copy of the ID/Passport of the candidate and must be sent by the expiry date indicate on the final ranking. The lacking of the email or of the attached copy of ID/Passport, will be considered as a waiver.**

Candidates admitted are requested to pay a stamp duty.

Students without fellowship are requested to pay a refundable local tax.

No tuition fee is requested by PhD students.

Admission to second and third year of the programme is subject to a positive evaluation by the Programme's Academic Board.

#### **Art. 12 – FELLOWSHIPS**

Fellowships are awarded for a period of three years and are confirmed yearly. If the number of available fellowships is less than the number of PhD positions, the fellowships will be awarded to the candidates following the position on the final ranking.

The fellowship amounts to € **15.343,82** gross per year; will be paid on a monthly basis and will include National Insurance Contributions (INPS) which fellowship recipients are required to pay.

The amount of the scholarship will be increased by 50% for research periods spent abroad that have been previously authorized by the PhD Programme Coordinator. Scholarships are non-cumulative and cannot be combined with other grants, except for those awarded by national or foreign scientific Institutions for activities related to study or research periods spent abroad.

A further 10% will be available from the second year programme for research periods in Italy and abroad.

Students earning more than €16,000,000 gross per year are not entitled to scholarships.

All cases of total or partial incompatibility for scholarship benefits are ruled by university regulations. In case of incompatibility, students will have to reimburse the amount of money unduly received. Reimbursements refer to an academic year or fraction thereof.

**Students cannot be awarded the doctoral fellowship twice.**

#### **Art.13 – DUTIES AND RIGHTS OF PhD STUDENTS**

After registering, doctoral students must activate an official email address ([name.surname@uniroma1.it](mailto:name.surname@uniroma1.it))

Doctoral students must attend the programme and carry out study and research activities on a full-time basis within the framework of the structures intended for this purpose. They also must fill in yearly the PhD programme evaluation form. Doctoral students may also conduct limited, additional or integrative teaching activities for no more than 40 hours per year. The Professors' Board defines the procedures and authorize teaching activities that do not compromise research training.

The PhD Programme Coordinator can authorize study periods abroad, according to research requirements, but the duration shall not exceed half of the duration of the programme (18 months).

Doctoral students who obtain unsatisfactory results during intermediate evaluations, who have unjustified prolonged absences or cannot be contacted over long periods, or exhibit behaviour that is not coherent with research deontology or general rules of good conduct can be excluded from the PhD programme following a motivated statement by the Board of Professors.

The Board of Professors can allow a temporary interruption of the attendance of PhD programmes in the following cases: maternity, military or civilian service, study or work opportunities compatible with a successive continuation of PhD activities, serious and documented illnesses.

PhD students working as public employees may benefit from scholarships but must accept a period of unpaid leave from the job for the whole duration of the programme. PhD students who are admitted to a programme without a scholarship, or refuse it, retain their salary as a public employee. If the employee resigns from the public administration, within two years after having obtained a doctoral degree, they must reimburse the salary paid during the PhD programme.

#### **Art. 14 - PhD DEGREE**

The Rector will award the PhD degrees at the end of a three-year doctoral programme to students who satisfactorily pass the final examination. Student admission to the final examination is communicated to the PhD Office by the Coordinator after approval by the Academic Board. The final examination cannot be repeated. Sapienza University issues a PhD Certificate. After the defence, candidates must load in the thesis on the University on-line System, IRIS.

The final thesis, if previously approved by the Board of Professors, can be written in a foreign language.

#### **Art. 15 – EXAMINATION BOARDS FOR PhD DEGREES**

The Rector will nominate the Examination Boards for oral defence of the thesis in accordance with the above-mentioned University PhD Regulations.

#### **Art. 16 – APPLICABLE REGULATIONS**
