DECREES

Students' enrolment in the restricted access **Cognitive Neuroscience** Master Degree Programme in English, class of the degree LM-51, for the 2019-2020 academic year, is subject to the participation in a procedure for the comparative assessment of qualifications and is divided into two time intervals called "selections": the <u>first selection</u> is open to non-EU citizens permanently resident abroad, the <u>second selection</u> is open to Italian, EU, and non-EU citizens legally staying in Italy.

1. Number of places available

The number of places available in the first selection, open to non-EU candidates permanently resident abroad, is equal to **20**.

The number of places available in the second selection, open to Italian citizens, Eu citizens wherever they may reside and to non-EU legally staying in Italy referred to in Article 26 of Law No. 189/2002, is equal to **20**.

2. Admission requirements

The first selection of the procedure for the comparative assessment is open to non-EU citizens permanently resident abroad that hold the qualifications and satisfy the curricular requirements listed below or who submit a declaration in which they state they are going to earn the qualification required by **2 September 2019**:

- Bachelor Degree in Psychology or a qualification earned abroad regarded as equivalent by the law in force;
- **B2** level English language certificate (ESOL, IELTS, TOEFL).

Students who do not hold a language certificate will have to attend an interview to have their level of English assessed on **9 September 2019** at 11:00 in classroom T (aula T), first floor, via dei Marsi 78 – Roma.

The second selection of the procedure for the comparative assessment is open to Italian citizens, EU citizens wherever they may reside and to non-EU citizens legally staying in Italy referred to in article 26 of the Law No. 189/2002, who hold the qualifications and satisfy the curricular requirements listed below or who submit a declaration in which they state they are going to earn the qualification required by **16 September 2019**:

- Bachelor Degree in Psychology or a 5-years Old University System Degree in Psychology or other qualifications earned abroad regarded as equivalent by the law in force;
- **B2** level English language certificate (ESOL, IELTS, TOEFL).

Students who do not hold a language certificate will have to attend an interview to have their level of English assessed on **9 September 2019** at 11:00 in classroom T (aula T), first floor, via dei Marsi 78 – Roma.

3. Methods and deadlines for registering for the comparative assessment procedure

To avoid being excluded from the procedure, candidates must:

a) submit their application using the platform on:

https://www.uniroma1.it/en/pagina/international-admissions-0 and enclosing the documents listed below:

- a copy of their passport (pdf);
- a brief motivation letter;
- the original copy of their English language certificate (ESOL, IELTS o TOEFL).
 The English language certificate requirement does not apply to students who earned a bachelor degree in English;
- certification of the credits (ECTS/CFU) achieved in the previous degree programme (in original or by way of self-certification, if it is an Italian qualification, using the form in Attachment 1);
- graduation certificate (in original or by way of self-certification if it is an Italian qualification, using the form in Attachment 1);
- up to two reference letters (optional);
- proof of payment of the € 35,00 registration fee (see point b) below).

b) paying the € 35,00 registration fee.

To make the payment you need to register on the Infostud system and download the personalised form following the instructions on <u>https://www.uniroma1.it/it/pagina/cognitive-neuroscience</u> and indicating the <u>registration code for the comparative assessment</u> <u>procedure: 25787</u>

The personalised form is at the same:

• self-certification of personal data;

- application for the comparative assessment procedure;
- payment slip for the registration fee.

On no account will the payment of the registration fee for the comparative assessment procedure be refunded. Payments processed using different methods from those hereby described will not be accepted.

Please Note: keep the registration number issued by the Infostud system because it is essential for the other stages of the procedure.

Any communications will be sent to the e-mail address that has been given when registering on Infostud. We recommend that candidates check the address is correct. Students that are already registered on the Infostud system must check/enter their e-mail address using the function User data (dati utente) > change access data (modifica dati accesso).

You may register for the <u>first selection</u> of the comparative assessment procedure open to non-EU citizens permanently resident abroad within <u>5 June</u> <u>2019.</u>

You may register for the <u>second selection</u> of the comparative assessment procedure open to Italian citizens, EU citizens wherever they may reside, and to non-EU citizens legally staying in Italy from <u>20 June 2019 to 19 July 2019.</u>

4. Applications' assessment criteria

Once the admission requirements have been checked, the ranking will be prepared taking into account the criteria below:

- weighted arithmetic mean based on the credits (ECTS/CFU) of the grades achieved in the exams of the Psychology field;
- assessment of up to 2 reference letters drafted by Professors that had the chance to know the candidate during his/her university studies.

The selection board may carry out a Skype interview too, to verify the candidate's skills. In the event of any tie, the younger candidate shall prevail.

5. Selection Board

The Selection Board for the procedure for the comparative assessment of qualifications referred to in the present call for applications is appointed by the Degree Programme Board and consists of the President of the Master Degree Programme in **Cognitive Neuroscience**, and of other three Professors of the Degree Programme.

6. Rankings

Once the terms for participating in the selections are over, the rankings for each selection, in which candidates are placed in descending order according to their score, are prepared.

6.1 - FIRST SELECTION RANKING PUBLICATION

The ranking for the <u>first selection</u> will be published with the students' registration number within <u>7 June 2019</u> on <u>https://www.uniroma1.it/it/pagina/cognitive-neuroscience</u> and with the candidates' list of names at the Faculty Student Affairs Office.

Non-EU citizens whose position in the ranking is amongst the first 20 candidates (successful) will receive an acceptance letter.

The other eligible (idonei) students whose position follows the first 20 candidates (eligible but not successful candidates) will receive a pre-acceptance letter.

Successful and eligible candidates interested in enrolling in the degree programme may immediately use the letters to apply for a visa.

6.2 – SECOND SELECTION RANKING PUBLICATION

The ranking for the <u>second selection</u> will be published with the students' registration number within <u>31 July 2019</u> on <u>https://www.uniroma1.it/it/pagina/cognitive-neuroscience</u> and with the candidates' list of names at the Faculty Student Affairs Office.

7.2 – ENROLMENT PROCEDURES

Enrolment procedures vary according to the different types of students, as follows.

- Successful candidates holding an Italian academic qualification must carry out the payment for the first instalment of tuition fees within the deadlines reported above, following the instructions available at: <u>https://www.uniroma1.it/it/pagina/cognitive-neuroscience</u> inserting the code 29388 on the payment form.
- Successful non-EU candidates and successful candidates holding an academic qualification achieved abroad (Italians, EU and non-EU citizens legally staying in Italy according to the Law No.189/2002, art. 26), in order to enroll, must go within the deadlines reported above to the *Hello-Foreign Students Office* to deliver the following documents:
- Certified copy of your high school diploma (achieved after at least 12 years of studies), translated into Italian, legalized and accompanied by the Declaration of Equal Value (DoV) issued by the competent Italian diplomatic authorities (Embassy or Consulate) of the country where the student obtained the title and in charge of the high school system.
- Certified copy of your University-level qualification (degree, diploma, title), translated into Italian, legalized and accompanied by the Declaration of Equal Value (DoV) issued by the competent Italian diplomatic authorities (Embassy or Consulate) of the country where the student obtained the title and in charge of the university qualification system.
- Photocopy of your academic transcript issued by your university, including all examinations taken, translated into Italian and legalized by the competent Italian diplomatic authority.
- Copy of your ID (Identity Card) or Passport.

- Copy of your residence permit card (only for Non-EU citizens regularly living in Italy). If you are renewing you residence permit card, you will need a copy of your expired residence permit card and the post office receipt of the renewal application request.
- Copy of your study Visa (only for Non-EU citizens living abroad).

7.3 – HOW TO PAY TUITION FEES

The payment for tuition fees must be carried out at any Italian Unicredit Group branch or online (for further information on payment methods go to <u>https://www.uniroma1.it/it/pagina/cognitive-neuroscience</u>); on the last day available for the payment, the online payment must be processed within the bank's closing hours (20.30).

7.4 – TUITION FEES

Students with foreign incomes, according to italian national law, (Governamental Decrete 159/2013, art 8) will pay as follows:

Students with national incomes can pay Tuition fees, in accordance with their financial standing - ISEE which must be calculated and certified by a Tax Assistance Centre (CAF)-(Approved by the Management Board on June 11, 2013) based on ISEE Form calculating their own fees amount

Every students but those who flagged the "I do not declare ISEE" option, must calculate their ISEE either at a CAF (Tax Assistance Centre), or online, on the INPS website using their PIN or SPID digital identity.

ISEE is an official form which indicates financial standing in any given year on the basis of family status, earnings, property and expences. Documents must be relevant to the year previous to the academic year in which the student is enrolling.

Please notice: Calculating ISEE at a CAF is a free operation, it takes many weeks and must be declared by December. Students are encouraged to require their ISEE certification as soon as possible.

8. Special cases

8.1 - TRANSFERRING FROM OTHER SAPIENZA UNIVERSITY DEGREE PROGRAMMES

Successful candidates already enrolled in other Degree Programmes at Sapienza must submit a transfer application to the Student Affairs Office of the degree programme they are coming from and hand the document at the Student Affairs Office of the new Faculty strictly within the enrolment deadlines.

Please Note: after having submit the transfer application, students will no longer be allowed to take exams for the degree programme they have come from.

8.2 - TRANSFERRING FROM OTHER UNIVERSITIES

Successful candidates coming from other Universities must submit their transfer application to the University they are coming from, and carry out the payment for the first instalment of tuition fees strictly within enrolment deadlines, following the instructions on page <u>https://www.uniroma1.it/it/pagina/cognitive-neuroscience</u> and paying a \in 65,00 contribution as a refund for transfer expenses, after having got the payment slip at the Student Affairs Office.

Please note: after having paid the transfer fee, students will no longer be allowed to take exams for the degree programme they have come from.

Please note: For enrollment procedures, all students with foreign titles, have to submit the list of mandatory documents as reported at point 7.2 at Hello – Foreign students

9. Withdrawal procedure after enrolment

Students who, after having enrolled, wish to withdraw from enrolment in the degree programme must go to the Student Affairs Office and submit a written declaration on stamp-impressed paper or on plain paper with a \in 16,00 revenue stamp on it.

Students who withdraw from enrolment have no right to receive a refund for the tuition fees they have already paid.
