## **Application and Enrolment Process**

(According to Artt. 3, 5-9, 2025-2026 Call for Applications) English

- 1. Register on INFOSTUD 2.0 (<a href="https://stud.infostud.uniroma1.it">https://stud.infostud.uniroma1.it</a>) with a valid email address and password and note the 7-digit Student ID Number issued by the system.
- 2. Pay within 16/06/2025 the €200 application fee on the PagoPA platform following the instructions at Art. 6, § 2 of the Call for Applications.
- 3. (For non-EU citizens residing outside of the Schengen area) **Submit within 30/06/2025 an application for a student visa on the UNIVERSITALY platform** (<a href="https://universitaly-private.cineca.it/index.php/registration/firststep">https://universitaly-private.cineca.it/index.php/registration/firststep</a>).
- 4. Fill in the dedicated Google Form (<a href="https://forms.gle/q3xGVjTVCnEhiB23A">https://forms.gle/q3xGVjTVCnEhiB23A</a>) within 16/06/2025 with all required information and upload the following documents:
  - a. Copy of Passport front page
  - b. Copy of application fee receipt
  - c. Copy of **High School Diploma** or equivalent (cf. Art. 6, § 5) along with translation in English or Italian and legalisation
  - d. Copy of the most recent **Transcript of Records**, along with translation in English or Italian, and legalization
  - e. Attestation of English language proficiency (cf. Art. 3, § 6)
- 5. Wait for the admission ranking to be published on the Sapienza Foundation Year webpage (foundation.year@uniroma1.it).
- 6. (For admitted candidates) Submit within 30/10/2025 to Sapienza's Hello—International Student Office (<a href="mailto:studentistranieri@uniroma1.it">student Office (studentistranieri@uniroma1.it)</a>) the following documents, to complete your enrolment:
  - a. Copy of Passport front page
  - b. (For non-EU citizens residing outside of the Schengen area) Copy of **visa** issued "for university enrolment 2025-2026"
  - c. (For non-EU citizens residing within the Schengen area) Copy of **residency permit card** or receipt of first issue/renewal request,
  - d. Copy of High School diploma, along with translation into Italian or English, and legalisation
  - e.
