# CALL FOR APPLICATIONS FOR THE 2025-2026 ACADEMIC YEAR FOR ADMISSION TO ADVANCED PROFESSIONAL COURSES THE RECTOR

HAVING REGARD TO Law No. 341 of 19 November 1990;

HAVING REGARD TO Ministerial Decree No. 270 of 22 October 2004; the Statute of the University of Rome 'La Sapienza';

HAVING REGARD TO the University Academic Regulations;

HAVING REGARD TO the 'Regulations governing Advanced Professional Courses

Courses, Advanced Education Courses, Continuing Education Courses, and Intensive Courses' issued by Rector's Decree No. D.R. 2774/2022 of 6 October 2022 (hereinafter referred to as the

'Regulations');

HAVING REGARD TO Law 33 of 12 April 2022, 'Provisions on concurrent enrolment in two

higher education courses';

HAVING REGARD TO Ministerial Decree No. 930 of 29 July 2022 containing: 'Provisions to

allow concurrent enrolment in two university courses';

HAVING REGARD TO Article 15, paragraph 1 of the Regulations governing doctoral

programmes, according to which attendance at doctoral programmes is incompatible with concurrent enrolment in other doctoral programmes and first and second level Advanced Professional

Courses programmes;

HAVING REGARD TO the resolution of the Academic Senate no. 217/25 of 23 September

2025 and of the Board of Directors no. 343/25 of 30 September 2025, which approved the proposal to update the educational offering relating to the Memorandum of Understanding between the Minister for Public Administration and Sapienza University of Rome concerning the enrolment of public administration staff in courses

#### **DECREES**

#### **Art. 1 - GENERAL PROVISIONS**

This call for applications contains the provisions regulating admission to the first and second level Advanced Professional Courses programmes listed in Annex 1 for the 2025-2026 academic year.

The **Regulations** and **Curriculum** for each programme are published on the individual Advanced Professional Courses programme webpage, which can be consulted at the following link: <a href="https://www.uniroma1.it/it/pagina/elenco-dei-master">https://www.uniroma1.it/it/pagina/elenco-dei-master</a>

#### Art. 2 - GENERAL ADMISSION REQUIREMENTS

First-level Advanced Professional Courses are reserved for holders of a first-level or higher academic degree or diploma, or other equivalent qualification or qualification issued abroad and recognised as suitable under current legislation.



Second-level Advanced Professional Courses are reserved for holders of a degree under the former system (prior to Ministerial Decree 509/99), a specialist degree, a Advanced Professional Courses degree, a second-level academic diploma or other equivalent qualification or qualification issued abroad and recognised as suitable under current legislation.

For the School of Medicine, holders of the qualifications referred to in Article 1, paragraph 10, of Decree Law No. 402 of 12 November 2001, converted into Law No. 1 of 8 January 2002, may also be admitted to first-level Advanced Professional Courses degrees. #### Art. 3 - ORGANISATION OF EDUCATIONAL ACTIVITIES AND ATTENDANCE

The educational programme typically lasts one year. The educational activities total 1,500 hours, of which at least 300 hours are dedicated to classroom teaching. The remaining hours may be used for other educational activities such as internships, seminars, conferences and conventions on topics related to the Advanced Professional Courses programme, individual study and preparation, and the final exam.

The annual teaching programme and the number of credits assigned to each activity are listed in the curriculum available on the webpage of each Advanced Professional Courses programme (https://www.uniroma1.it/it/pagina/elenco-dei-master).

Attendance at the course's teaching activities is compulsory and must be certified.

As a rule, absences exceeding 25% of the total number of hours of lessons will result in the student being unable to take the final exam and obtain the qualification.

In the event of non-attendance, poor performance, failure to pay fees regularly or conduct that is otherwise reprehensible, the Advanced Professional Courses Scientific Teaching Council may decide to dismiss or exclude the participant. In such cases, the enrolment fees paid will not be refunded.

#### Art. 4 - NUMBER OF AVAILABLE PLACES

All Advanced Professional Courses programmes have limited enrolment. The maximum and minimum number of students required for each Advanced Professional Courses programme to run are indicated in the **Regulations**, which can be consulted on the webpage for each Advanced Professional Courses programme (<a href="https://www.uniroma1.it/it/pagina/elenco-dei-master">https://www.uniroma1.it/it/pagina/elenco-dei-master</a>).

The places available for civil servants under the Programma PA 110 e lode are indicated in Annex 1. The term 'surplus' means that there is no maximum limit on the number of students who can enrol.

# Art. 5 - REGISTRATION WITH THE INFOSTUD INFORMATION SYSTEM AND ENTRY OF UNIVERSITY QUALIFICATION

In order to participate in the admission competition, candidates must, **under penalty of exclusion**:

- obtain a Sapienza registration number by registering on Infostud 2.0 at Infostud 2.0 | Sapienza University of Rome (uniroma1.it);
- enter their university degree on their Infostud profile, which is required for admission to the Advanced Professional Courses programme, according to the following instructions: go to the page <a href="Students">Students</a> | Sapienza University of Rome (uniroma1.it) access Infostud 2.0> Profile> University degrees;



- enter your bank account details on your Infostud profile, which will be needed for any refunds: go to the <u>Students | Sapienza University of Rome (uniroma1.it)</u> page and log in to Infostud 2.0> Profile> Account. Please note that the bank account must be in the student's name.

To access Infostud, you will need your SPID or CIE credentials.

Only non-Italian candidates who do not have SPID credentials can access the system using their Infostud registration credentials (student ID number and password).

Those who have already registered with Infostud in the past do not need to repeat the procedure, but can log in to the system directly.

#### Art. 6 - PAYMENT OF THE ADMISSION TEST / QUALIFICATION ASSESSMENT FEE

The candidate is required, **under penalty of exclusion**, to pay the admission/assessment fee of € 51.00 (€ 35.00 fee + €16.00 stamp duty paid virtually), to be paid **by 31 January 2026**.

Payment of the above fee is due in all cases, even if you are participating in third-party procedures to obtain scholarships (INPS executive, INPS Junior, etc.) for which the outcome is not yet known.

The above contribution is also due from candidates for positions reserved for public administration employees under the 'Programma PA 110 e lode'.

Payment must be made within the terms set out in this call for applications and is also due in the case of qualification assessment only.

To make the payment, follow these steps:

Payment of the admission test fee must be made online by direct payment.

Payment methods other than those specified will not be accepted, nor will complaints due to failure to pay by the deadline indicated above. Candidates are therefore requested to complete the procedure well in advance of the deadline to allow the offices to provide the necessary assistance if required.

The fee for the admission test/assessment based on qualifications is non-refundable for any reason, except for a refund of € 35.00, excluding stamp duty, if the Advanced Professional Courses programme is not activated. Any refund will be made to the bank account whose IBAN has been registered in the Infostud profile (see Article 5).

#### Art. 7 - SUBMISSION OF APPLICATION AND ADMISSION DOCUMENTS

**By 31 January 2026**, candidates, **under penalty of exclusion**, must send the following documents to the email address published on the webpage for each individual Advanced Professional Courses programme <a href="https://www.uniroma1.it/it/pagina/elenco-dei-master">https://www.uniroma1.it/it/pagina/elenco-dei-master</a>:

- Application form as per Annex 2, duly completed and signed;
- Photocopy of a valid identity document (identity card driving licence passport);



- Curriculum vitae
- Copy of the receipt for payment of the admission test/qualification assessment fee of € 51.00, paid in accordance with the methods indicated in Article 6 of this notice.

In addition to these documents, which are mandatory for all applicants, the following documents must also be submitted if you belong to one or more of the following four categories:

#### 1) Applicants with qualifications awarded abroad

- ✓ Certificate of equivalence of qualification issued by the Italian consular authority in the country of study (with a transcript of records + copy of the final diploma) or
- ✓ CIMEA Statement of Comparability together with CIMEA Verification Certificate
  (accessible on the CIMEA platform: <a href="http://www.cimea.it/it/servizi/attestati-di-comparabilita-e-certificazione-dei-titoli/attestati-di-comparabilita-e-di-verifica-dei-titoli-diplome.aspx">http://www.cimea.it/it/servizi/attestati-di-comparabilita-e-di-verifica-dei-titoli-diplome.aspx</a>)
- ✓ Diploma Supplement (if it is a European qualification) issued by the university of origin and legalised at the Italian Embassy in the country of study or
- ✓ authorisation decree from the Italian Ministry of Health to practise the profession.

Those who submit incomplete documentation will be provisionally admitted and will not be able to complete their enrolment in the Advanced Professional Courses programme. Any missing documents may be supplemented no later than the deadline for the first instalment referred to in Article 10 below.

Non-EU citizens residing abroad must comply with the interministerial provisions as set out in the circular 'Procedures for the entry, stay and enrolment of foreign/international students in higher education courses in Italy for the academic year 2024-2025', available at the following link: <a href="https://www.studiare-in-italia.it/studentistranieri/">https://www.studiare-in-italia.it/studentistranieri/</a>.

Those who need to apply for a study visa must submit an online pre-enrolment application at <a href="https://www.universitaly.it/">https://www.universitaly.it/</a> and send notification of submission to: settoremaster@uniroma1.it

- 2) Applicants with recognised disabilities pursuant to Article 3, paragraphs 1 and 3, of Law No. 104 of 1992 and/or with a disability equal to or greater than 66%:
- ✓ copy of the disability certificate or Law 104/92 issued in accordance with the law, under penalty of exclusion from the benefits provided; the same certificate must also be sent to the Students with Disabilities and SLD Department at the following email address: servizio.disabilita@uniroma1.it
  - 3) Candidates who are simultaneously enrolled in another course at Sapienza University of Rome for the academic year 2025-2026 and are interested in enrolling in a Advanced Professional Courses programme in the same academic year, and who have verified that there is no incompatibility with the course they are attending:
- ✓ concurrent enrolment form referred to in Annex 3 of this Call for Applications.

Please note that, pursuant to Article 15 of the Sapienza PhD Regulations, attendance at PhD courses is incompatible with concurrent enrolment in first and second level Advanced Professional Courses programmes.

Students with concurrent enrolment will have their student number duplicated, in order to manage the two academic careers separately.



Please note that the dual enrolment form is not required in the case of concurrent enrolment in courses at other universities.

- 4) Candidates who are employed by public administrations and who intend to take advantage of the benefits provided for in the <u>Memorandum of Understanding PA 110 e lode</u>:
- ✓ substitutive declaration of certification as per Annex 4 of this Call for Applications.

The benefits provided for in the PA 110 e lode Memorandum of Understanding are available exclusively for Advanced Professional Courses programmes participating in the programme for the academic year 2025-2026. The Advanced Professional Courses programmes concerned are listed in Annex 1 to this Call for Applications, together with the places available.

Applications with incomplete documentation, submitted in ways other than those specified in this call for applications, sent to email addresses other than those published on the webpage of each individual Advanced Professional Courses programme (<a href="https://www.uniroma1.it/it/pagina/elenco-dei-master">https://www.uniroma1.it/it/pagina/elenco-dei-master</a>) or submitted after the deadline will not be accepted.

#### **Art. 8 - ADMISSION PROCEDURE**

To be admitted to the Advanced Professional Courses programme, applicants must hold one of the university degrees (as referred to in Art. 2 of this call for applications) indicated in the admission requirements described in the **Curriculum** for each individual Advanced Professional Courses programme

(https://www.uniroma1.it/it/pagina/elenco-dei-master).

If an entry exam is required, it will be held for each Advanced Professional Courses programme in accordance with the procedures described on the webpage for each individual Advanced Professional Courses programme (https://www.uniroma1.it/it/pagina/elenco-dei-master).

#### Art. 9 - PUBLICATION OF THE LIST OF ADMITTED CANDIDATES / RANKING

At the end of the assessment of qualifications and/or any entry exam, the list of admitted candidates will be published on the webpage of each Advanced Professional Courses programme. The publication of the list of admitted candidates shall serve as notification for all purposes. If the number of candidates exceeds the number of places available, candidates will be placed in a special ranking list and only those who are among the top-ranked candidates in the above-mentioned list will be admitted to the Advanced Professional Courses programme; candidates who are eligible will be admitted to the Advanced Professional Courses programme only if one or more of the top-ranked candidates withdraw.

# Art. 10 - PAYMENT OF THE ADVANCED PROFESSIONAL COURSES PROGRAMME ENROLMENT FEE

Candidates admitted to the Advanced Professional Courses programme must pay the first instalment or single instalment of the enrolment fee **no later than 28 February 2026.** The amount to be paid for enrolment, together with the reduced amount for Advanced Professional Courses programmes participating in the PA 110 e lode Memorandum of Understanding, is published on the webpage of each individual



Advanced Professional Courses programme (<a href="https://www.uniroma1.it/it/pagina/elenco-dei-master">https://www.uniroma1.it/it/pagina/elenco-dei-master</a>). The payment schedule in two instalments or a single instalment is indicated in the Regulations published on the webpage of each individual Advanced Professional Courses programme.

To make the payment, follow the procedure below:

- access Infostud from the page <a href="https://www.uniroma1.it/it/pagina-strutturale/laureati">https://www.uniroma1.it/it/pagina-strutturale/laureati</a>;
- select in sequence: Advanced Professional Courses programme > First year > Enter the course identification code (found in Annex 1 of this call for applications) > Continue. After generating the payment slip on Infostud, the PagoPA button will be activated and payment must be made as indicated at the following link: How to pay

If the list of admitted students has been published, pursuant to Article 10(1) of the 'Regulations', those admitted to the Advanced Professional Courses programme who do not pay the first instalment **by 28 February 2026** will be required to pay a late payment surcharge of € 65.00. Sixty days after the deadline specified in the call for applications, the surcharge will be double the ordinary amount.

If a merit ranking has been published in accordance with Article 10(2) of the 'Regulations' and there are eligible students who could take their place, those admitted to enrolment who do not pay the first instalment **by 28 February 2026** will be considered to have withdrawn. Any enrolment of the same applicant may only take place after the ranking list has been completely exhausted.

The deadline for paying the second instalment is **30 May 2026.** 

To make the payment, follow the procedure described for the payment of the first instalment. Failure to comply with the payment terms for the second instalment will result in the application of a late payment surcharge of € 65.00. If the payment of the second instalment is made more than 60 days after the deadline specified in the call for applications, the surcharge will be double the ordinary amount.

Pursuant to paragraph 9 of Article 12 of the 'Regulations', students who are not up to date with the payment of fees and contributions, for the entire period to which the aforementioned non-payment refers, may not take exams, attend courses, internships or carry out any career-related activities, nor may they be entitled to apply for certificates.

Beyond the deadlines, students are not allowed to prepare the respective payment forms online from the Infostud 2.0 system. Therefore, it will be necessary for the Director of the Advanced Professional Courses programme to authorise late payment by sending a request to: <a href="mailto:settoremaster@uniroma1.it">settoremaster@uniroma1.it</a>.

It is possible to use the **Teacher Card** to cover all or part of the required fee. In this case, before the deadline indicated in Art. 10, participants admitted to the course must send an email to: <a href="mailto:settoremaster@uniroma1.it">settoremaster@uniroma1.it</a>, by also attaching the bonus generated by the MUR website in order to receive, again by email, instructions on how to pay the balance, if any, between the course registration fee and the amount of the bonus.

Art. 10 bis – REDUCTION IN REGISTRATION FEES FOR CIVIL SERVANTS UNDER THE 'PA 110 E LODE' PROGRAMME

Civil servants who meet the requirements set out in the 'PA 110 e lode' programme pay the reduced enrolment fee as indicated on the webpage of each individual Advanced Professional Courses programme participating in the programme (see Annex 1).

During the same academic year, it is possible to take advantage of the benefits provided for in the PA 110 e lode Memorandum of Understanding for enrolment in only one programme, either at Sapienza or at other universities.

The payment of enrolment fees for civil servants by institutions is not permitted. After the degree has been awarded, within 30 days of the transfer of funds from the Department of Public Administration to this University, Sapienza will reimburse 50% of the enrolment fee paid, up to a maximum of € 2,500.00. No refunds will be issued in the

**INPS** Executive grants are incompatible with the benefits provided by the PA 110 e lode project. Therefore, candidates who have indicated, during the application process, their intention to join the PA 110 e lode programme and who subsequently become beneficiaries of an INPS Executive grant, are required to immediately notify the University by sending an email to: <a href="mailto:settoremaster@uniroma1.it">settoremaster@uniroma1.it</a>. If the student has already paid the first instalment or single instalment (discounted under the PA 110 e lode programme), the University will refund the amount paid (with the exception of the entry exam fee) upon request by the interested party.

Participation in the "PA 110 e lode" initiative **is incompatible** with any other scholarship, grant, subsidy, or other award, however named, recognized by any public or private body, intended to support study

# Art. 10 ter - REDUCTION OF ENROLMENT FEES FOR STUDENTS WITH DISABILITIES

Students with disabilities pursuant to Art. 3, paragraphs 1 and 3, of Law No. 104 of 5 February 1992, and/or with a disability equal to or greater than 66%, are exempt from paying 50% of the enrolment fee, without prejudice to any other exemptions established by the Regulations (Article 30, paragraph 9 of the 'Regulations').

To generate the reduced payment, you must select the 'Student with disability' exemption on Infostud in self-certification, also indicating the type of disability.

Students with disabilities referred to in the first paragraph of this article must send an email to the Students with Disabilities and SLD Department at: <a href="mailto:servizio.disabilita@uniroma1.it">servizio.disabilita@uniroma1.it</a>, specifying the name of the Advanced Professional Courses programme or the related code, a copy of the disability certificate - indicating the percentage of disability, or, for cases provided for by law, only the type of disability - or the disability certificate pursuant to Article 3, paragraphs 1 and 3, of Law No. 104 of 5 February 1992.

The financial assistance referred to in this article shall take effect from the date of submission of the application and cannot be retroactive except for the current academic year, taking into account the date of submission of the application for the recognition of disability.

The 50% exemption from the enrolment fee reserved for students with disabilities and the possible 50% refund of the enrolment fee provided for in the PA 110 e lode Memorandum of Understanding for civil servants who obtain a degree cannot be combined. Therefore, in this case, the refund referred to in Article 10bis of this call for applications shall not apply.



#### Art. 11 - CONDITIONAL ADMISSION OF UNDERGRADUATE CANDIDATES

Undergraduate candidates who do not hold the qualification required for admission to the Advanced Professional Courses programme and who wish to participate in this call for applications must, in addition to registering with Infostud as provided for in Art. 5 above, declare their status as undergraduates by clicking on Profile - University Qualifications and selecting the '*Undergraduate*' flag. They must then follow the procedures for paying the entry exam fee referred to in Art. 6. They will be provisionally admitted to the Advanced Professional Courses programme and, in the event of a ranking list, will be placed at the bottom of the list.

#### The degree must be obtained no later than 31 March 2026.

In order to be duly enrolled in the Advanced Professional Courses programme, the candidates in question must notify the Director of the Advanced Professional Courses programme and <a href="mailto:settoremaster@uniroma1.it">settoremaster@uniroma1.it</a> by email, within 10 days of obtaining their degree and under penalty of forfeiture of their enrolment, that they have obtained their degree; They will receive an email with instructions on how to pay the enrolment fee, without any surcharge for late payment, to be paid by the deadline indicated on the payment slip.

Candidates who have not obtained their degree from Sapienza Università di Roma are also required to update their academic career in their Infostud profile, by entering the date of graduation and the related grade in the 'Profile - University degrees' section, and by removing the flag in the 'undergraduate' box.

#### Art. 12 - FUNDING AND/OR GRANTS

Funding may be made available to enrolled students by external bodies affiliated with the Advanced Professional Courses programme to cover part or all of the enrolment fee. This funding is awarded according to criteria and procedures defined and made public by the funding body. Any grants, partial or total exemptions from enrolment fees already known at the time of publication of this call for applications are indicated in the Curriculum for each Advanced Professional Courses programme, available at the link: https://www.uniroma1.it/it/pagina/elenco-dei-master

Payment methods in the case of funding by a company: In order to fund the enrolment of one or more students in a Advanced Professional Courses programme, the beneficiaries of the funding must register on Infostud and obtain a student number, in accordance with the procedures indicated in point 5, and then complete the following steps:

**Step 1)**: the financing company must send an email to: <a href="mailto:settoremaster@uniroma1.it">settoremaster@uniroma1.it</a> requesting the details and methods for making the payment and indicating the name(s) of the beneficiary(ies) and the Advanced Professional Courses programme code.

**Step 2)**: after making the payment, the company must send an email with its details (name, VAT number/tax code, address, postcode and city).

#### Art. 13 - AUDITORS



Where provided for in the **Regulations**, individuals who do not meet the admission requirements may be admitted to the Advanced Professional Courses programme as supernumerary auditors.

The registration fee for auditors is 30% of the Advanced Professional Courses programme registration fee.

Those interested must express their interest by email to the Director of the Advanced Professional Courses programme and to: <a href="mailto:settoremaster@uniroma1.it">settoremaster@uniroma1.it</a>, who will confirm acceptance of the request and provide information on the timing and methods of enrolment and payment of the participation fee.

Auditors cannot be counted in the minimum number required for the Advanced Professional Courses programme to run.

Auditors may not under any circumstances participate in workshops or internships, take the final exam or earn credits.

At the end of the Advanced Professional Courses programme, auditors who have met the minimum attendance requirement may be issued a certificate of participation by the Advanced Professional Courses programme administrative office.

#### **Art. 14 - INDIVIDUAL COURSES**

Those who meet the same admission requirements as those for the Advanced Professional Courses programme may enrol in individual courses of a Advanced Professional Courses programme, where provided for by the **Regulations**, up to a maximum of 20 credits.

Those enrolled in individual courses may take the relevant exams and obtain certification of the credits acquired from the Director of the Advanced Professional Courses programme.

If the Advanced Professional Courses programme is not activated, the related individual courses cannot be activated unless they are converted into Advanced Education Courses.

Credits acquired in individual courses within the Advanced Professional Courses programme may be evaluated for the purposes of enrolment in other university courses. The minimum enrolment fee for each course is calculated based on the number of credits to be acquired, as indicated in Article 17, paragraph 5 of the 'Regulations'.

To be authorised to enrol in an individual course and find out how to make the required payment, you must send a request by email to the Director of the Advanced Professional Courses programme and to <a href="mailto:settoremaster@uniroma1.it">settoremaster@uniroma1.it</a>.

#### **Article 15 - WITHDRAWAL**

Admitted participants who intend to withdraw from the Advanced Professional Courses programme must notify the Director of the Advanced Professional Courses programme in writing at the email address available on the institutional webpage of each course (<a href="https://www.uniroma1.it/it/pagina/elenco-dei-master">https://www.uniroma1.it/it/pagina/elenco-dei-master</a>) and at <a href="mailto:settoremaster@uniroma1.it">settoremaster@uniroma1.it</a>. Any registration fees already paid are non-refundable (Art. 16, paragraph 9 of the 'Regulations').

# Art. 16 - PROCEDURES FOR TAKING THE FINAL EXAM AND OBTAINING THE DEGREE

The procedure for taking the final exam is indicated in the Curriculum for each Advanced Professional Courses programme, available at the link <a href="https://www.uniroma1.it/it/pagina/elenco-dei-master">https://www.uniroma1.it/it/pagina/elenco-dei-master</a>.

The exam is conducted in person before an Examination Board, which awards a mark out of 110/110 and may, by unanimous decision, award the candidate the highest mark



with honours. The minimum mark required to pass the exam is 66/110 (sixty-six/one hundred and ten).
