1. Admission to the degree programme and available places

To gain admission to the Master's degree programme in **Design, Multimedia and Visual Communication** you will have to participate in a procedure for comparative assessment of qualifications and pass an admission test.

The criteria for assessing qualifications and academic knowledge are laid down in [section 3.4](#).

The available places are distributed as follows:

Master's degree programme	EU places (Note 1)	Non-EU places (Note 2)
Design, Multimedia and Visual Communication (Class LM-12)	60	40 (of which 2 reserved to Chinese citizens of the "Marco Polo" project)

(Note 1) – Posti riservati a chi: Places reserved for:

- candidates with Italian or other EU citizenship, or
- citizens with non-EU citizenship holding a valid residence permit in Italy

(Note 2) – Places reserved for:

- candidates with non-EU citizenship, permanently resident abroad who applied for a student visa
- candidates with Chinese citizenship who participate in the Sapienza University of Rome "Marco Polo" project.

If enrolment applications from applicants who have non-EU citizenship, reside permanently abroad and have applied for student visas (specified in Note 2), are less than the number of available places, the vacant places will be made available for candidates with citizenship as specified in Note 1.

The Master's Degree programme in Design, Multimedia and Visual Communication offers two different curricula:

- Design, Multimedia and Visual Communication, in Italian language;
- Design, Multimedia and Visual Communication, in English language.

2. Requirements for participation in the selection

2.1 - For candidates with Italian citizenship, EU citizenship other than Italian, and non-EU citizenship with a valid residence permit in Italy

If you hold one of the citizenships listed below:

- Italian citizenship,
- from a EU country other than Italy,
- from a non-EU country and a valid residence permit in Italy (art. 26 of Law no. 189/2002)

To participate in the selection, you must meet the requirements listed below by **September 1ST, 2026**

- **A bachelor's degree** in Industrial Design class L-4, ex 42, obtained in all Italian universities; or an equivalent first-level degree in design obtained in Italy (including, for example, public and private Design Schools with diplomas equivalent to class L4 and recognised by the Ministry of University and Research; ISIA diplomas; diplomas from public and private Fine Arts Academies with qualifications recognised by the Ministry of University and Research) and in European Union universities or in any case through courses for which it is possible to establish correspondences between subjects and Scientific-Disciplinary Sectors.
- **Bachelor's degree in a class other than class L-4, ex 42, in Industrial Design**, provided they have

a total of at least 40 ECTS obtained in the sectors ICAR/13; ICAR/14, ICAR/16; ICAR/17; ING-INF/05; SPS/08; L-ART/03; L-ART/05; L-ART/06; SECS-P/08.

Please Note: Candidates who have **graduated in another degree class** are required to submit a graduation certificate with the list of exams taken.

When calculating ECTS, the credits of a single exam may only be counted once, even if the relevant scientific-disciplinary sector is present among both foundation and core educational activities.

For candidates applying for the International Curriculum in English, the correspondence between qualifications and the relevant disciplines will be established.

- **Advanced knowledge of the English language**, at least level B2 according to the Common European Framework of Reference for Languages (CEFR). Adequate knowledge of the English language at level B2 will be certified by candidates by sending a scanned copy (scanned in .pdf format) of their language certificate or self-certification attesting to their knowledge of the language.

2.2 - For candidates with non-EU citizenship who apply for a visa for study purposes and choose the English language curriculum

If you are a non-EU citizen (or have Chinese citizenship and have applied for pre-enrolment for the "Marco Polo" project for Sapienza University of Rome in the academic year 2025/2026) reside abroad and you need to apply for an incoming student visa, you must meet the following requirements on **July 13, 2026**, in order to take part in the selection process:

- **qualifications and curricular requirements** deemed equivalent to those listed above (for qualifications obtained abroad, see Annex 1 to this call for applications, [section A1.5](#));
- **Advanced knowledge of the English language** (at least level B2), according to the Common European Framework of Reference for Languages (CEFR). Adequate knowledge of the English language at level B2 will be certified by candidates by sending a scanned copy (scanned in .pdf format) of their language certificate or self-certification attesting to their knowledge of the language.
- **Pre-acceptance letter** for the degree programme in Design, Multimedia and Visual Communication Downloaded in .pdf format following successful pre-selection by May 15, 2026 from <https://www.uniroma1.it/en/admissions>. The pre-acceptance letter must be downloaded from the MoveIn platform no later than the deadline for payment of the €35 fee required for the selection of who hold citizenship of a non-EU country and permanently reside abroad ([section 3](#)).

Please Note: the pre-acceptance letter from the University does not confer any right to obtain a visa, nor to enrol in the Degree Programme in Design, Multimedia and Visual Communication.

To enrol, you must pass the comparative assessment procedure and admission test, in the methods indicated in this call for applications.

You will not be admitted to the programme if:

- You do not receive the provisional acceptance letter via the MoveIn platform;
- You receive the provisional acceptance letter but do not accept the offer within the deadlines specified above;
- You receive the provisional acceptance letter, accept the offer but do not pass the subsequent selection stage.

- **Online pre-enrolment application**, for obtaining the entry visa for study purposes "University enrolment" for the academic year 2026-2027, on the University website (<https://www.universitaly.it/>) filled in and sent compulsorily by June 30, 2026. Pre-registration on the University website is mandatory in order to obtain the student entry visa.

Please Note: pre-enrolment alone does not allow admission to degree programmes. In order to enrol, it is necessary to complete the procedures provided by Sapienza University of Rome for the chosen degree programme, as indicated in this call for applications.

For candidates with non-EU citizenship, permanently residing abroad, who apply for a visa for study purposes that choose the Italian Language Curriculum

they are not obliged to get the pre-acceptance letter and besides the requirements listed above must have passed

- **the Italian language proficiency test** (level B2), or must have an Italian language certificate of at least level B2, issued by recognised organisations (<https://www.esteri.it/it/diplomazia-culturale-e-diplomazia-scientifica/cultura/promozionelinguaitaliana/certificazioni-linguistiche>) as indicated in the Ministry of University and Research Circular. If you are ranked on the list and have submitted an application for a student visa

2.3 - For candidates already holding a degree

If you already hold a second-level academic qualification (obtained in Italy or abroad) and if you come from other university degree or diploma programmes, you are required to comply with the same procedures set out in the following sections and take part in the comparative assessment procedure.

2.4 – For candidates graduating within January 31, 2027

If you are pursuing a Bachelor's degree at Sapienza University of Rome in Industrial Design (L-4), **or in other degree classes**, by **January 31, 2027**, you may **conditionally** participate in the selection process.

Any applications from those about to graduate from other universities than Sapienza will be excluded.

Please note: Sapienza University of Rome graduating students in other degree classes are required to submit the study plan of the Degree Programme (see [section 3.3](#))

3. Selection

The procedure for participating in the selection involves the following stages:

Register on Infostud and pay the €35.00 fee	From June 16, 2026, to July 13, 2026 (if you are a citizen of a non-EU country and permanently resident abroad) From June 16, 2026 to September 1, 2026 (if you are a EU citizen or a non-EU citizen but you hold a valid residence permit in Italy)
Apply for participation in the procedure for the comparative assessment of qualifications	By July 13, 2026 (if you have citizenship from a non-EU country and reside permanently abroad) By September 1, 2026 (if you are a EU citizen or a non-EU citizen but you hold a valid residence permit in Italy)
Take the admission test	July 17,20 and 21, 2026 (if you have citizenship from a non-EU country and reside permanently abroad) September 7,8 and 9, 2026 (if you are a EU citizen or a non-EU citizen but you hold a valid residence permit in Italy)

3.1 – Infostud registration

To register on Infostud you will have to enter your data in the form available on the Sapienza University of Rome website, under the heading Register

If you hold **Italian** citizenship Spid or Cie credentials are necessary.

Please Note

The e-mail address you enter when registering will be used for any communications from the University, so please check your e-mail box periodically during the steps of the procedure.

If you already have an Infostud registration you have to verify/enter your email address on the Idm dashboard, logging in with your Spid/Cie credentials or with your student ID number and password

3.2 – Payment of the €35 fee

To pay the €35 fee:

- Log in to Infostud <https://www.uniroma1.it/en/pagina-strutturale/students> with your Spid or CIE credentials (if you have non-Italian citizenship you will have to use your student ID number and password)
- Click on “Bachelor’s and Master’s Degree Programmes”;
- Go to “Admission to programmes”;
- Enter the code **12951**
- Go to Continue and then Next
- Click on Direct Payment (PagoPA)

The payment of the fee must be made by **direct payment** (online, by credit card).

The fee for participation in the comparative assessment will not be refunded for any reason.

3.3 – Application for the comparative assessment

To apply for the procedure for comparative assessment of qualifications, you have to fill in an online form and include the required documents.

Please Note: Incomplete applications or applications not received by the deadlines indicated in [section 3](#), will result in exclusion from the comparative assessment procedure.

Sapienza University of Rome may proceed with exclusion from the selection procedure at any time for lack of the requirements.

Fill in the application

To fill in the application, you need to log on to the course catalogue, type in the programme's name "Design, Multimedia and Visual Communication" and go to the "Apply" section, where you will find the application procedure.

Documents to include in the application

- **ID document**
- **Scanned copy** (scanned in .pdf format) of the €35 fee **payment receipt**
- **Scanned copy** (scanned in .pdf format) of the **language certificate or self-certification of English language proficiency** (B2 level).

Applicants with EU citizenship or non-EU citizens who hold a valid residence permit in Italy must also have:

- Curriculum Vitae (.pdf format)
- Portfolio (.pdf format)
- Graduation certificate with the list of exams taken

If you graduated in a class other than L-4 (ex42) you must also have the

- Graduation certificate with the list of exams taken

If you are graduating from Sapienza University of Rome in a class other than L-4, you will have to include the

- Study plan of the Bachelor's Degree Programme.

If you hold non-EU citizenship and apply for a visa for study purposes

- Before submitting your application for the comparative assessment procedure, you must complete the **pre-selection application** on the QS MoveIn platform and submit the **pre-enrolment application** on Universitaly as indicated in [section 2.2](#)

3.4 – Qualifications assessment

The assessment of qualifications for an **overall score of 60 points** will refer to the following two fields:

Final Bachelor's degree assessment* (compulsorily reported in the google form) with a score ranging from a minimum of 2 to a maximum of 30 points and **Portfolio assessment**.

** For Sapienza University of Rome graduating students, the assessment will be based on the average grade of the exams taken with a score ranging between 2 and 15 points.*

For candidates with a Bachelor's degree who meet the entry requirements, points will be awarded as follows:

a) **Up to 30** points can be attributed in descending order to the **graduation** grade***:

* In the case of grading systems other than systems with a score calculated out of 110, the original grade (hundredths, marks, etc.) has to be converted to the above-mentioned scale.

** In the case of international - non-European - degrees in which the grade and/or graduation grade is not applicable, the selection board, having consulted the Hello-International student office on the grading systems adopted by the country of origin of the candidate under consideration, will, on a case-by-case basis, report the grade in the equivalent grade adopted for all the other candidates.

b) **Portfolio assessment** with a score **between 0 and 30 points** including:

- a summary of the graphic design or multimedia* projects developed as part of the bachelor's degree;
- a summary of graphic or multimedia* design projects developed as a professional activity in a freelance capacity or as a collaborator in agencies and professional studios;
- information on other diplomas and/or certificates of attendance at postgraduate specialisation courses; 1st level master's degrees; courses on softwares, and in any case related to the field of Visual and Multimedia Communication Design;
- information relating to the awarding of prizes in design competitions in the field of graphic and multimedia communication; participation, as an author, in national and international exhibitions and collectives in the field of graphic and multimedia communication; participation in workshops and training and professionalising internships promoted by bodies, institutes, organisations in the fields of graphic and multimedia communication; participation in national and international scientific conferences in the field of graphic and multimedia communication;
- copies of books, essays, authored papers or articles or copies of specific publications on the projects realised; proceedings of national and international conferences.

* For multimedia projects, it is possible to include frames and links to repositories (Youtube, Behance, etc.).

For candidates who will graduate from Sapienza University of Rome the assessment of qualifications will refer to the study plan previously completed, which, since they do not have a final degree assessment (graduation grade), will be evaluated in accordance with the following grades:

a) Up to a maximum of 15 points can be attributed to **the average grade of the exams** taken:

TABLE OF THE SCORES OF EXAMS TAKEN

The average is calculated by summing the grades of all exams taken, the result is then divided by the number of exams.

A grade of 30 with honours should be calculated as 31.

It is mandatory that students also include the average grade in the form attached to the application and not only the list of exams with the corresponding grades.

b) **Portfolio assessment** with a score **between 0 and 30 points** including:

- a summary of the graphic design or multimedia* projects developed as part of the bachelor's degree;
- a summary of graphic or multimedia* design projects developed as a professional activity in a freelance capacity or as a collaborator in agencies and professional studios;
- information on other diplomas and/or certificates of attendance at postgraduate specialisation courses; 1st level master's degrees; courses on softwares, and in any case related to the field of Visual and Multimedia Communication Design;
- information relating to the awarding of prizes in design competitions in the field of graphic and multimedia communication; participation, as an author, in national and international exhibitions and collectives in the field of graphic and multimedia communication; participation in workshops and training and professionalising internships promoted by bodies, institutes, organisations in the fields of graphic and multimedia communication; participation in national and international scientific conferences in the field of graphic and multimedia communication;
- copies of books, essays, authored papers or articles or copies of specific publications on the projects realised; proceedings of national and international conferences.

In the rankings, in the event of a tie between graduates, the duration of bachelor's degree studies (regular or *fuoricorso*) prevails in favour of regular graduates (candidates who graduated within the regular duration of the programme). In the event of a further tie, the date of graduation prevails (i.e. those who graduated on the first available date and session of the same academic year). In the event of a further tie, age prevails in favour of younger candidates.

Candidates with a degree in a degree class other than L-4 ex 42 must enclose, in pdf format, the graduation certificate indicating, for each exam taken at the university of origin, *the number of credits (ECTS)* and the *corresponding scientific-disciplinary sector*. Candidates who do not receive recognition of at least 40 ECTS will not be included in the final rankings.

The above data must be requested from the Student Affairs Offices of the Faculty of origin.

3.5 – Oral test

The oral test is aimed at assessing academic knowledge and will focus in particular on portfolio commentary. The score reserved for the oral test is a **maximum of 10 points** awarded according to the following criteria:

- A. 9-10 points for excellent mastery** of the knowledge and skills underlying the implementation of the activities described in the portfolio;
- B. 7-8 points good command** of the knowledge and skills underlying the implementation of the activities described in the portfolio;
- C. 5-6 points sufficient command** of the knowledge and skills underlying the implementation of the activities described in the portfolio;
- D. 3-4 points poor command** of the knowledge and skills underlying the implementation of the activities described in the portfolio;
- E. 1-2 points insufficient command** of the knowledge and skills underlying the implementation of the activities described in the portfolio.

The oral test will take place

- on **July 17, 20 and 21, 2026** for non-EU candidates who need to apply for a student visa
- on **September 7, 8 and 9, 2026** for candidates with EU citizenship or non-EU citizenship with a valid residence permit in Italy

The schedule of the oral tests and how they will be conducted will be published on the official website of the degree programme, in the "Apply" section, by

- **July 16, 2026**, for non-EU citizens who need to apply for a student visa
- **September 4, 2026**, for candidates with EU citizenship or non-EU citizenship with a valid residence permit in Italy

3.6 - Disabilities or Specific Learning Difficulties

Indications for candidates with a certified disability or a diagnosis of specific learning (SpLDs) difficulties can be found in [Annex 2](#).

4. Rankings and deadlines

Once the assessments have been completed, the rankings will be drawn up, in descending order of points obtained.

The rankings, expressed in a score out of 70, will be drawn up according to the following criteria:

- 60 points are determined by the comparative assessment of qualifications
- 10 points are determined based on the result of the oral test

A minimum of 15 points is required to be admitted to the ranking list.

The rankings will be published in the course catalogue <https://corsidilaurea.uniroma1.it/en> on the degree programme page. The online ranking list will be published by student ID number only; the list of names will be available at the Faculty's Student Affairs Office.

Publication will take place by

- **July 30, 2026**, for non-EU candidates who need to apply for a student visa
- **September 15, 2026**, for EU candidates and non-EU candidates with a valid residence permit in Italy

Candidates who gained a successful position in the rankings will have to pay enrolment tuition fees

- From **September 1 to September 29, 2026**, for non-EU candidates who need to apply for a student visa
- From **September 15 to September 29, 2026**, for EU candidates and non-EU candidates with a valid residence permit in Italy

If you obtain your degree in Sapienza after the deadline for payment of enrolment tuition fees **and by January 31, 2027**, and you are successful in the ranking list, you must submit a declaration of intention to enrol at the Student Affairs Office of Architecture, before the deadline for payment of enrolment tuition fees (precautionary application [section 5.3](#)).

Please Note

If you do not pay the enrolment tuition fees by the deadline, you will lose your place in the rankings: vacant places will be allocated according to the ranking list.

If you have not yet graduated and you do not submit your precautionary application by the deadline (see [section 5.3](#)), you will lose your place in the rankings and the vacant places will be allocated according to the ranking list.

In this respect, a subsequent list of new intakes from the ranking list will be published with the following schedule:

October 6, 2026	Publication of the first list of new intakes from the ranking list and opening of enrolments for the candidates that become successful
October 15, 2026	Deadline for paying enrolment tuition fees

Any subsequent new intakes from the ranking list will be managed solely by the Student Affairs Office by means of communications to the email address indicated when registering on Infostud. In this regard, it is recommended that you check your e-mail inbox.

Once you have enrolled, you will be able to complete your choice of Curriculum (in ITA Italian language or ENG English language) by filling in your study plan on the GOMP platform.

5. Enrolment

Final enrolment in the degree programme is obtained by paying the first instalment of the programme's enrolment tuition fees for the 2026-2027 academic year, to which the €16.00 stamp duty and regional tax must be added.

The procedure is described on the page available at the following link:

<https://www.uniroma1.it/it/node/24689>. The code to be entered is **33432**.

During the payment procedure, you can enter any conditions for exemption from tuition fees and regional tax. The €16.00 stamp duty is still due even in the case of total exemption from tuition fees.

It is extremely important at this stage to have obtained the Isee 2026 calculation for the right to academic education in order to take advantage of the exemptions and benefits provided on the basis of this indicator ([Annex 3](#)).

5.1 – For candidates who change from another degree programme at Sapienza University of Rome

If you are successful in the ranking and are currently enrolled in another Sapienza programme, and you wish to request credit for exams taken in your previous programme, you must follow the instructions provided on the Sapienza website. [Go to the page](#)

The application for degree programme change must be sent by email no later than the deadline for payment of enrolment tuition fees indicated in [section 4](#), listing as recipients both the Student Affairs Office of the programme you belong to and the Student Affairs Office of the programme you wish to enrol in ([section 7](#)).

In the email addressed to the Student Affairs Office, you must specify your position in the ranking list.

Please note: after submitting your application to transfer, you will not be able to sit the exams for your degree programme of origin.

5.2 – For candidates who transfer from another Italian university

If you are successful in the ranking and you are actively enrolled in another degree programme at an Italian university, and you wish to request recognition of the exams you have taken in your previous program, you must pay the tuition fee for your new chosen degree programme no later than the deadlines specified in [section 4](#). Within ten days of paying the tuition fee, you must submit a transfer application.

After payment of enrolment tuition fees, you will not be able to sit exams for your home degree programme.

5.3 – For candidates who have not yet graduated

If you are successful in the ranking and you graduate **between the deadlines for payment of tuition fees and December 31, 2027**, you must submit the precautionary application, no later than the deadlines indicated in [section 4](#), using the following procedure:

5.4 – For candidates already holding an Italian academic degree

5.5 – For candidates with an educational qualification obtained within a non-Italian higher education system

6. Withdrawal from enrolment

If, after paying your tuition fees, you want to withdraw from enrolment, you must follow this procedure:

MoveIn platform again by May 15, 2026 (<https://www.uniroma1.it/en/admissions>), and the pre-enrollment process via the University online platform (<https://www.universitaly.it/>) no later than June 30, 2026. Annex 1. Citizenship in foreign countries and/or qualifications obtained within a foreign education system

A1.1 – Citizenship in EU and non-EU countries holders of a residence permit in Italy (non EU equivalent)

Follow the general procedures set out in the call for applications if:

- a. you are a citizen of one of the European Union countries or one of the following countries: Norway, Iceland, Liechtenstein, Switzerland, the Republic of San Marino, the Vatican City State;
- b. you hold dual citizenship, one of which is of a European Union country
- c. you are a national of a non-EU country, but hold one of the following residence permits issued by the Italian State:
 - EU long-term residence permit
 - Residence permit for employment or self-employment
 - Residence permit for family reasons
 - Residence permit for political asylum, subsidiary protection or special reasons
 - Residence permit for religious reasons
 - Residence card under Article 50 TEU – Article 18.4 of the EU-UK Withdrawal Agreement.
- d. you are a citizen of a non-EU country, but have been legally resident in Italy for at least one year and hold a secondary school qualification obtained in Italy that grants access to your chosen degree programme, or hold a degree or an accredited Foundation Year certificate obtained at an Italian university, duly recognised by the Ministry of Education, Universities and Research (MUR), in the 2025/2026 academic year;
- e. you are a citizen of a non-EU country and are duly enrolled on a degree course at an Italian university, hold a valid residence permit for study purposes and intend to apply for a transfer or progression (for years following that of initial enrolment);
- f. you are a non-EU citizen and you (or one of your parents or your spouse) are a member of staff serving in foreign diplomatic missions and international organisations based in Italy, accredited to the Italian State or the Holy See. In this case, you must submit your residence permit for diplomatic purposes.

If you hold a residence permit for study purposes in Italy issued for

- attending an Italian language course
- undertaking an exchange/mobility period
- attending a 'single course'

please follow the instructions set out in [point A1.3](#)

A1.2 – Dual citizenship

If you have dual citizenship, one of which is Italian or from another EU country, your Italian citizenship or that of the other EU country prevails (Law No. 218 of May 31, 1995, Article 19, paragraph 2), and therefore, to enroll in the degree programme indicated in this call for applications, you must follow the instructions provided for those who hold citizenship in an EU country and in a non-EU country with a valid residence permit in Italy (non-EU equivalents)

A1.3 - Citizenship in non-EU countries, residence abroad and application for a student visa

If you are a citizen of a non-EU country, reside in a country other than Italy and do not meet the requirements set out in [point A1.1](#), you must apply for an entry visa for study purposes, as indicated in [point 2.2](#) in order to enrol on the course specified in this call for applications.

If you are a non-EU citizen and hold a residence permit for study purposes in Italy issued to attend an Italian

language course or to undertake an exchange/mobility period, in order to enrol on the degree programme covered by this call for applications, you must return to your country of origin and submit an application for an entry visa for study purposes as indicated in [point 2.2](#).

A residence permit for study issued for a 'single course' will be considered valid for university enrolment as an EU equivalent only if all three of the following requirements are met in the 2025/2026 academic year:

- You regularly attended the single course and passed the relevant assessment
- The single course attended is relevant to the degree programme chosen for your subsequent academic career.

Annex 2. Services for disabilities or Specific Learning Difficulties (SpLDs)

A2.1 - Recognised disability/invalidity

If you have a disability recognized under Article 3, paragraph 1 or 3, of Law No. 104 of February 5, 1992, or a disability certification, and you require special aids or additional time to take the exam, you must indicate this request on the Infostud System during the process of generating the payment for the exam registration fee and send the certification to testaccesso.inclusione@uniroma1.it

Special circumstances will be considered based on the certifications submitted.

Requests must be received no later than the exam registration deadline and must be accompanied by appropriate certification issued by INPS or the relevant National Health Service (S.S.N.) facilities.

A2.2 - Specific learning disorders

If you have been diagnosed with a Specific Learning Disorder (SLD), as defined by Law No. 170/2010 and Ministerial Decree No. 5669/2011, and require special aids or additional time for the exam based on the type of SLD, you must indicate this request on the Infostud System during the process of generating the payment for the exam registration fee and send the certification to testaccesso.inclusione@uniroma1.it.

Requests must be received no later than the exam registration deadline and must be accompanied by appropriate certification of the SLD issued by National Health Service (S.S.N.) facilities or by specialists and facilities accredited by the S.S.N.

If the attached documents do not specify the accreditation of the facilities or specialists who issued the certification, you must include a note confirming such accreditation.

The SLD certification must be detailed and clear, including references to nosographic codes and an explicit description of the SLD (reading and/or writing and/or math). The diagnosis must have been issued no more than three years ago if it pertains to minors.

A2.3 - Disability/invalidity and SLDs for those residing in foreign countries

If you reside abroad and have a recognized disability or a diagnosis of a learning disability (DSA) and wish to take advantage of the opportunities described above, you must submit a legalized certification—if required by applicable international regulations—attesting to your disability or DSA status, issued in your country of residence, accompanied by a sworn translation by an official translator or a translation certified as conforming to the original text by Italian diplomatic missions, in Italian or English.

Annex 3. Isee for the right to academic education

The Isee (Indicator of Equivalent Economic Situation) for the right to academic education is required to obtain a reduction in the amounts of tuition fees to be paid by the student (the lower the Isee value, the lower the amount to be paid).

The calculation of Isee for university right to academic education benefits should be requested from Tax Assistance Centers (CAF) after January 15, 2026, and at least 30 days before the enrolment deadlines.

For candidates with a PIN code or SPID digital identity (unique code for access to all digital and online services of the Public Administration), it is also possible to request the calculation of Isee 2026 directly online by submitting the DSU (Single Substitute Declaration) on the INPS website (www.inps.it).

For candidates who have foreign citizenship and/or declare income earned abroad and are therefore unable to produce Isee certification, there is a fixed amount tuition fee, depending on their country of origin.
