

ERASMUS+ MOBILITY FOR TRAINEESHIPS

What is the "Erasmus Plus- Student Mobility for traineeships"?

Erasmus+ Mobility for traineeships" is an action funded by the European Commission under the "Erasmus+" programme, which enables students to perform a traineeship mobility at an enterprise or organization in another participating country, with the aim of fostering their development of professional skills and competences.

Traineeships may start between the 1st September 2025 and must end by 31st July 2026 and they must be carried out without interruption.

Students are granted € 450-500 per month and you are not therefore required to give students any financial support.

Your company may contribute through an optional salary or any other additional contribution, like free meals or accommodation or free ground transportation.

What are the advantages of hosting an Erasmus+ trainee?

- The Erasmus+ trainee can introduce new ideas into the working environment and undertake projects that require qualified competencies, increasing the workforce whenneeded without any obligation of permanent employment by your company;
- The linguistic knowledge of the trainee can provide you with new opportunities for making business contacts across domestic and foreign labour markets.

What do companies interested in hosting an Erasmus+ trainee have to do?

If you have been contacted by a student from the University of Rome la Sapienza asking you to arrange an Erasmus+ traineeship, and if you accept to support his/her application, you will have to agree with him/her the following issues:

- the starting date and ending date (between the first of September 2025 and the end of July, 2026)
- the traineeship contents (activities to be performed, learning outcomes, etc.)
- the language skills required for the traineeship. You may check his/her language skills yourself (by phone interview, for example), and declare if the evaluation the trainee fulfills the language requirements;
- the identification of a tutor who will supervise and assist the student; the tutor will also keep in touch with us (Erasmus Unit, erasmustirocini@uniroma1.it, tel +39 06 49690437)
 In order to confirm your traineeship offer, our student will request you to fill, sign and stamp the document "Letter of acceptance" that the student has to upload in his application form, for an Erasmus+ traineeship grant within our call's deadline 28 March 2024
