

INFORMATION SHEET FOR WORKERS WHO HAVE HAD CASUAL CONTACT WITH CONFIRMED COVID-19 CASES

Dear Worker,

You have reported low-risk contact (casual contact)¹ with a confirmed case of SARS-CoV-2. We are asking you to take specific actions and follow certain recommendations to protect your and other people's health.

We recommend that for 14 days after the contact you:

- measure your body temperature at least twice a day (if you are using medications, e.g. paracetamol, which may mask the onset of fever, contact your General Practitioner);
- if within 14 days a fever (with a body temperature >37.5°C/99.5°F) or other symptoms should appear, with particular attention to respiratory symptoms (colds, coughs, sore throats, difficulty in breathing, alterations in smell or taste) and gastrointestinal symptoms (nausea, diarrhoea, vomiting), please inform your General Practitioner as soon as possible, as well as the CMO's Doctor supervising your structure, and contact the regional toll-free number 800 118 800. Pending assessment by the personnel of your ASL, you are required to self-isolate.

To carry out the actions recommended by the Ministry of Health, we ask you to provide us with your data and contact details, which may be forwarded to your local health authority if necessary, following public health regulations.

It is understood that any action will be carried out with absolute respect for your privacy and that any further measures will be explained to you in advance.

Sapienza's Centro di Medicina Occupazionale (CMO) will be able to provide you with useful information on your case by emailing emergenza.covid19@uniroma1.it.

Low-risk contact (casual contact) is defined by Ministry of Health Circular No. 36254 of 11/08/2021 as:

[•] a person who has had direct (face-to-face) contact with a COVID-19 case, at a distance of less than 2 metres and for less than 15 minutes;

[•] a person who has been in an enclosed environment (e.g. classroom, meeting room, hospital waiting room) or who has travelled with a COVID-19 case for less than 15 minutes;

[•] a healthcare worker or other person providing direct assistance to a COVID-19 case or laboratory personnel handling samples of a COVID-19 case, wearing recommended Personal Protective Equipment (PPE);

[•] all passengers and crew of a flight on which a COVID-19 case was present, except for passengers seated within two seats in any direction of the COVID-19 case, fellow passengers and section personnel.

Longer contact duration increases the risk of transmission; the 15-minute limit is arbitrarily selected for practical purposes. Based on individual risk assessments, public health authorities may consider extending contact tracing and management to persons who have had a shorter duration of contact with a case. on the aircraft/train where the index case was seated who are in fact classified as high-risk contacts.
