





Philipp Schwartz

- Professor of Pathology at the University of Frankfurt
- dismissed in 1933 under the “Law for the Restoration of the Professional Civil Service” (*Berufsbeamtengesetz*) and fled Germany to escape arrest
- founded the “Notgemeinschaft deutscher Wissenschaftler im Ausland”
- placed nearly 2,000 dismissed academics in posts abroad until 1946





Background

- Founded in 2015 by the Alexander von Humboldt Foundation in cooperation with the Federal Foreign Office
- Financial and institutional support from Federal Foreign Office
- Pilot phase: additional funding from private sources
- At-risk scholars in all academic disciplines, from all countries of origin outside EU
- Third party confirmation of severe personal risk





Facts & Figures I

- 24-month fellowship/employment at postdoc level (fully-funded)
- Optional 12-month extension (co-financed with host institution)
- Auxiliary funds for the host institution: €20,000 per fellow hosted





Facts & Figures II

Since programme launch in 2016:

- approx. 330 Philipp Schwartz Fellows
- approx. host 100 institutions
- main countries of origin: Turkey, Syria, Iran
- 21 others, including Afghanistan, Belarus, Brazil, Cameroon, Iraq, Myanmar, Venezuela, Yemen

Bridging Fellowships for Afghanistan

- 20 bridging fellowships for Afghan scholars recently evacuated to Germany, in transit countries, or in Afghanistan
- 12-month research fellowship (fully funded)
- 5.000 EUR auxiliary funds: language training, career coachings...
- HEI as nominating and hosting institutions
- Call for nominations: late January

ESU - European Students' Union

- The European Students' Union (ESU) is the umbrella organisation of 45 National Unions of Students (NUS) from 40 countries and 13 European sectoral student federations as Associate Members.

The NUSes are open to all students in their respective country regardless of political persuasion, religion, ethnic or cultural origin, sexual orientation or social standing.

Our members are also student-run, autonomous, representative and operate according to democratic principles.





Our Aim

- The aim of ESU is to represent and promote the educational, social, economic and cultural interests of students at the European level towards all relevant bodies and in particular the **European Union, Bologna Follow Up Group, Council of Europe and UNESCO**. Through its members, **ESU represents almost 20 million students in Europe**.
- ESU's mission is to **represent, defend and strengthen students' educational, democratic, political and social rights**. ESU will work for sustainable, accessible and high quality higher education in Europe.



2015: 'Refugees welcome'

- In 2015, **1.3 million people** (mostly Syrians, Iraqis, Afghans) demanded asylum in Europe ([Pew Research Center](#));
- The European University Association [developed](#) the '**Refugees Welcome**' map with all the initiatives to support refugees by universities in Europe (not available anymore);
- EUA's projects [TandEM](#) (integration between third country national and youth communities in southern Europe) and [inHERE](#) (support of integration of refugees and displaced people into Higher Education)

2016-2021: ESU's Together Moving Forward

- Inspire student-led initiatives addressing refugees' and asylum seekers' living conditions and not least their access to education;
- Reshape public discourse around forced migration and confront hate speech in our societies;
- Build capacity for students to be more responsive to issues related to forced migration, focusing on social inclusion and access to education;
- Empower National Student Unions to promote and advocate for clear policies that ease the access of refugees and asylum seekers to Higher Education;
- Open up to new student groups and other stakeholders active on refugee issues, especially education;
- Build long-lasting links between newcomers, and student communities.

2020-2021: the Belarusian and Afghan crises

- 2020: After the Belarusian presidential elections, at least 600 students received some form of penalty due to their activism (including arrests);
- 2021: Taliban takeover in Afghanistan led many people to flee the country, including students;
- EU4Belarus-SALT: programme of scholarships to study in Latvia, Lithuania, Czechia or Poland;
- Global Campus on Human Rights: scholarships for Afghan scholars and students at risk for the academic year 2021/2022;

General programmes for students at risk

- Norwegian '[Students At Risk](#)' programme;
- German '[Hilde Domin](#)' programme;
- Nominations from Higher Education Institutions and student unions;
- Addressed to students at risk of persecution in their countries.

Limits of the current programmes

- Limited hosting capacity;
- Lack of linguistic diversity hinders eligibility for incoming students, especially from Spanish- and French-speaking countries,
- Limited number of intakes per year;

These can be overcome with an international scheme coordinating the national ones.

Towards a European 'Students At Risk' scheme

- **ESU/EUA/SAR:** condemning the repression in Belarus, jointly called for the establishment of a European 'Students At Risk' scheme;
- **DAAD (DE)/HK-dir (NO)/ NAWA (PL):** call for a European 'Student At Risk' scheme, with a **single entry-point** for users, as a **coordination of national schemes** plus **co-funding** under Erasmus+ to be established by 2024;
- **ESU/GSF/SAIH:** the scheme must have a **fast lane for emergencies and humanitarian crises**; **multiple application periods** per year; combine the 'student' and 'refugee' approaches, collaborating with UNHCR in establishing humanitarian corridors; sufficient **financial and bureaucratic and administrative support**.

Creation of PAUSE

August 2015 : Assassination of Khaled al-Assaad, the former director of antiquities and museums of Palmyra in Syria, and mobilization of the archaeological community

January 2016 : Petition *Academics for Peace* followed by a massive repression in Turkey

January 2017 : Official launch of PAUSE with the signing of the framework agreement between the Ministry of Higher Education and Research and the Collège de France



Missions

- **Co-funding of institutions** seeking to host a scientist or artist forced into exile through three calls for applications per year.
- **Support for researchers** with identifying a host institution and accessing common law services
- **Accompaniment of beneficiaries** towards a sustainable professional insertion.
- **Advocacy actions** to uphold academic freedom and protect researchers and artists in exile.

Who is eligible?

- **Doctoral student, Researcher, Professor or Artist-Teacher** who can justify his/her status
- **In an emergency situation** due to the security context, persecution because of his/her ethnic origin, political commitment, opinions, or the content of his/her research and/or teaching
- Regardless of his/her current place of residence: **being forced into exile** or **has been forced to leave his/her country of origin less than 3 years ago.**







Challenges and perspectives



On a national scale

- **Perpetuate the funds: Necessity to diversify PAUSE funding**
- **Accompany the professional integration of beneficiaries after the program support:**
 - Allocation of additional funding of up to €5,000 upon presentation of a training plan by host institutions
 - Organization of workshops and personalized support in collaboration with integration professionals
 - Creation of an alumni network for PAUSE beneficiaries
 - Contribution to research projects and valorization of the PAUSE laureates' expertise through the organization of scientific and cultural events



On an international scale



- Develop European and International partnerships to strengthen the reception and integration of scientists and artists in exile

- Bilateral cooperation with counterpart programs in Europe and internationally:

PAUSE response to the Afghan crisis



- A coordinated response within the French higher education and research community
- A response adapted to the needs:
 - Additional public funding
 - Identification of host institutions
 - Adaptation of the eligibility criteria
 - Organization of an exceptional session for Afghan scholars and artistes (October 2021)
- **27 Afghans including 9 Phd candidates and 5 artists selected in October**
=> 80 Afghans indirectly supported by PAUSE
- 1 emergency procedure underway
- Mobilization of the French public authorities (MFA and ministry of Interior) to enable the laureates to arrive in France
- Collaboration with the International and European partners

Funding

- Main funding from HEI
- 6 million SEK from Riksbankens jubileumsfond 2017-2021
- 5 million SEK from Riksbankens jubileumsfond 2021-2023
- 6 million SEK from Formas 2022-2024



Swedish support programme for scholars from Afghanistan

- 17 m. sek (≈ 1,6 MEUR)
- 2022-2024
- Funded by Sida
- 10 placements for scholars from Afghanistan for 23 months
- Covers 70% of the costs, 30% in co-funding from hosting institution



Establishing a protection programme

- Respond to a current need
- Build on existing good examples in Europe but be adapted to the national premises
- Aim at a long-term and sustainable solution
- Solution that covers all research areas and countries
- Complementing already existing programmes, f.ex UNICORE (University Corridors for Refugees)
- Remember that a protection programme is not the one solution, but that various initiatives in needed to also f. ex support students in country.
