#### THE RECTOR

WHEREAS The Law n. 341 of 19 November 1990;

WHEREAS The Ministerial Decree 22 October 2004 n. 270;

WHEREAS Articles 3, 5, 18 and 19 of the Sapienza University Didactic Regulation (first part) issued on 3 June 2008 with Rector's Decree n. 000547;

WHEREAS The Regulation D.R. n. 000502 of 20 May 2010 for founding, activating and managing University Master courses, Advanced Qualification and Qualification courses;

WHEREAS The resolution of the Academic Senate dated 15/09/2011, with which the Master was founded;

WHEREAS The resolution of the Academic Senate dated 14 May 2013, with which the list of courses offered by the Sapienza University for the academic year 2013/2014 was approved;

#### **DECREES**

the activation of the First Level University Master in "European and International Policies and Crisis Management", for the academic year 2013/2014, at the Faculty of Economics of the Sapienza University of Rome.

#### 1 - Goals

The First Level Master course on "European and International Policies and Crisis Management" provides a postgraduate training answering to the need for professionalism in national and international bodies and no-profit organizations. The Master provides the students with theoretical and professional preparation on different issues connected to the functioning of International Organizations as well as with the professional know-how necessary for the operational management of regional, national and international institutions, for policy-making and good governance in public, private and no-profit organizations.

# 2 – Organization of formative activities

The course is taught entirely in the English language and it has an interdisciplinary nature.

The formative activity is equivalent to 1,500 hours of study, of which at least 300 hours are classes and 250 hours' workload for the final project work. The remaining hours are dedicated to individual study and an Internship (or alternative activity assigned by the Scientific and Didactic Committee).

The Master teaching activity is organized in modules related to specific professional profiles. In the following, the credits of each formative activity (one credit corresponds to 25 hours student workload), including the final exam, are reported:

At the end of one or more module, written or oral or multiple choice tests will be carried out to assess the level of learning achieved by the participants.

Altogether the aforementioned didactic activities allows the acquisition of 60 university formative credits (UFC), in addition to the credits acquired during previous study required to gain access to the Master programme. The didactic activities will be carried out in Rome at the Faculty of Economics, Via del Castro Laurenziano 9, or in the premises of partner institutions of Sapienza University of Rome.

The internships, in area subjects related to the Master, will be carried out in national or international, public or private bodies. A partial list of the main organisations offering internships is available at: <a href="https://www.eurosapienza.it">www.eurosapienza.it</a>.

The organization where the internship will be done will be communicated directly to each students well in advance of its commencement. The Master lectures begin on 20 January 2014 and end in July 2014. The other activities are completed by the end of December 2014.

Attendance is obligatory (the signature of the participants to each class is collected). If the hours of absence of a participant overcomes the 25% of the total number of hours of class activities, he or she cannot get the Master Degree. In case of poor attendance or profit or unacceptable behavior, the Master Scientific and Didactic Committee may decide the suspension or exclusion of the participant. In such cases, the already paid fees are not reimbursed.

#### 3 – Duration and number of available posts

The Master course lasts one year. The maximum number of participants is fixed at 30. The minimum number of registered students necessary to activate the Master is 12.

# 4 – Admission requirements

In order to participate in the Master, candidates should master the English language and be holders of any at least three year degree or any other qualification which is considered in Italy equivalent to a university degree.

Holders of a Degree issued according to the university system preceding the law 509/1999, or of an equivalent qualification issued by a Higher Education Institution and/or in the frame of inter-university agreements of cooperation and mobility, may be admitted to the Master after prior evaluation of the cultural coherence of this qualification made by the Master's Scientific and Didactic Committee.

#### 4.1 – Qualified Admission (admission with reservation)

Graduating candidates can be admitted "with reservation" to the selection and they must inform the Master's office as soon as they get the title within:

- the 15th of January 2014 for students attending a BAC 3 at the Sapienza University of Rome (art. 30, par. 2 of the General Study Programme);
- the 31st of January 2014 for students attending a Master of Science or Arts at Sapienza University of Rome (art.8, par. 4 of the General Study Programme);
- the 17<sup>th</sup> of December 2013 for students attending courses in other Italian universities (art.30, par. 3 of the General Study Programme).

Students admitted with reservation cannot participate in competitions for scholarships based on the admission evaluation list.

#### 4.2 - Admission of students sitting in on lessons

In accordance with art. 4 of this notice, holders of a university qualification, who would like to deepen specific Master subjects and/or enrich their professional preparation, may be admitted as "Students sitting in on lessons" to attend Master modules (for a number of credits not exceeding 20). At the end of the related modules, participants will get a certificate of attendance by the Master Director.

#### 5 – Incompatibility

In accordance with art. 142 of T.U. 1592/1933, it is not allowed the contemporary registration to courses of study of the same or another level, in Italian or foreign Universities or Higher Education Institutions. On the other hand, courses of Professional and Higher Qualification are compatible.

#### 6 – Participation modalities

In order to participate in the admission competition, candidates must comply with the following modalities:

# 6.1 - Registration with the Infostud information system

Before presenting the application, Master candidates must previously register with the information system of Sapienza University of Rome. Candidates must follow the instructions in the website: <a href="https://www.uniroma1.it/studenti/">www.uniroma1.it/studenti/</a> and click on "REGISTRATI". At the end of the registration, the system will release a matriculation number which must be reported in the application form.

If the candidate is already registered as a student of Sapienza University of Rome, <u>he/she</u> <u>need not register again</u>, but must use his/her previous matriculation number in the application form.

Candidates must **assure that their academic qualifications** for the admission to the Master are included in their Infostud profile after following these steps on the Internet:

log in with matriculation number and password – DATI UTENTE – INF.

Graduating candidates, instead of inserting their graduation date, must follow the same steps of in the previous box and check LAUREANDI.

#### 6.2 - Selection fee and Tax

Candidates must pay a selection fee of  $\in$  35.00 plus a tax of  $\in$  16.00. The total amount of  $\in$  51.00 may be paid in any bank office of Unicredit Bank in Italy before and not later than this notice's expiry date (deadline for admission to the Master's course). The payment of € 51.00 may also be made **MASTERCARD** online DINERS. VISA credit cards by or (see http://www.uniroma1.it/studenti/tasse/pagamenti.php). To do the online payment, candidates must get in advance the personalised form available at: www.uniroma1.it/studenti/infostud, (click on ACCEDI DIRETTAMENTE), insert matriculation number and password and follow the steps: TASSE - PROVA DI ACCESSO - write the Master's code number: 14382 - AVANTI - STAMPA.

If the number of candidates does not reach 12 and the selection process is not done (neither through qualification nor through competition), the selection fee of  $\in$  35 will be reimbursed (the tax of  $\in$  14.62 is not reimbursable) following a written communication from the Master's Director submitted to the Sapienza University Master Office.

# 6.3 – The application

The application form is attached to this notice (Annex 1). It must be presented duly filled and signed together with the following documents:

- Photocopy of a valid identity document, duly signed and easy to read (ID card driving license passport);
- Photocopy of the Italian Tax Code (from abroad, it can be provisionally be obtained on the internet <a href="http://codicefiscale.it/">http://codicefiscale.it/</a> by inserting in the proper fields: Surname (Cognome), Name (Nome), Gender

(Sesso), non-Italian State of birth, date of birth (day/month/year).

- Photocopy of the receipt of the payment made to participate in the selection;
- Self-certification, as of the D.P.R. 445/2000, regarding: a) the Degree (declaration including the date in which it was obtained and the final grade/mark), and b) the transcript of exams passed with indication of the related grades/marks (final-year students must declare the expected Degree session and final date indicated in art. 4.1);
- Curriculum of the studies and professional activities;
- Declaration of consent to use personal data (Annex 3);
- Self-certification (as of D.P.R. 445/2000) of any other document or qualification the candidate would like to present for evaluation in the selection process.

# Presentation of the application by candidates with non-Italian qualifications

By the expiry date of this notice, candidates with non-Italian qualifications must present to the EuroSapienza office, together with the application form (Annex I), the following documents:

- Degree certificate with the list of exams and marks, translated and legalized by the Italian Embassy or Consulate in the Country in which the qualification was issued;
- Declaration of value (Dichiarazione di valore) of the Degree released by the Italian Embassy in the Country where the Degree was issued. The declaration of value is necessary to evaluate if the level of the title allows the admission to the Master.

All admission requirements have to be fulfilled before the application deadline.

The Declaration of value of the Title of study obtained in a non-Italian country must be annexed to the application.

The duly filled-in application form, together with the documents listed in 6.3, not later than the **16**<sup>th</sup> **of December 2013**, must **reach** the Master Director, Prof. Maurizio Boccacci Mariani.

It can be either hand delivered or sent by courier (or "Postacelere" or registered mail), to the following address of:

Applications with incomplete documentation or arriving after the deadline will not be accepted.

In case of postal sending, only the receiving stamp (and not the expedition one) is valid. Candidates sending the application by mail do accept the risk of its late arrival.

The application may be delivered by hand to the Master Secretariat on Tuesdays, Wednesdays and Thursdays from 10 a.m. to noon, located at the EuroSapienza Research Centre of the Sapienza University of Rome, Faculty of Economics (2<sup>nd</sup> floor), Via del Castro Laurenziano 9, 00161-Rome ITALY.

The application may be presented in only one of the ways described above.

#### 7 – Selection process

The admission to the Master depends on a positive evaluation of academic qualifications and their validity. An interview on general culture and knowledge of the English language is foreseen. The interview will take place on the 19<sup>th</sup> of December 2013, at 10 a.m. in the Faculty of Economics (classroom XIII), Via del Castro Laurenziano 9, Rome.

The candidates will be interviewed by the Master Director and a Selection Committee.

At the end of the selection, at least 20 days before the enrolment fee payment date, as stated in the following art. 8. the Committee will publish the list of merit of the candidates on the *EuroSapienza* news board, on the website <a href="www.eurosapienza.it">www.eurosapienza.it</a> and on the Sapienza website <a href="www.uniroma1.it/didattica/offerta-formativa/master">www.uniroma1.it/didattica/offerta-formativa/master</a>. This publication is officially informing all interested parties and therefore no individual communication will be sent on the selection results.

#### 8 – Registration

Selected students only may register with the Master. To be regularly registered, the selected students must pay a fee of € 4,700. The payment may be made either in one installment by 3 February 2014 or in two installments of € 2,350 each, the first by the 1<sup>st</sup> of February 2014, and the second by the 30<sup>th</sup> of April 2014. To make the payment, students must download the relevant form on <a href="https://stud.infostud.uniroma1.it">https://stud.infostud.uniroma1.it</a>, by entering the matriculation number and password and then selecting, in order: TASSE – IMMATRICOLAZIONE – MASTER/SPECIALIZZAZIONE – insert course code: 14382 - AVANTI - STAMPA. After printing the paying-in slip from Infostud, the payment may be made in any Italian branch of UniCredit Bank:

If the student is holder of a UniCredit account, he/she must write its number and sign the payment slip;

- online by credit card (Diners, Visa, MasterCard), by filling in the form in <a href="https://www.uniroma1.it/didattica/tasse/pagamenti">www.uniroma1.it/didattica/tasse/pagamenti</a>; the data requested are those in the payment slip printed from Infostud; The outcome of the operation will be communicated by UniCredit via email to the address given by the student during the payment process. Students who pay online via credit card must therefore ensure that they receive the aforementioned notification via email.
- with direct charge on a bank account, only for UniCredit online clients, on <a href="https://www.unicredit.it/it/privati.html">https://www.unicredit.it/it/privati.html</a>;
- **by a bank account cheque** issued by UniCredit or another bank, with same amount as the fee, issued:
- 1) either in favour of the student, as the beneficiary, and endorsed while paying the fee;
- 2) or issued from the bank account of the student to UniCredit.

In both cases, the cheque has to be "non-negotiable" and will be accepted by the bank "subject to clearance" and without any expenses for the depositor.

Note that, to pay the fees online, it is not necessary to open an account at the UniCredit bank. The enrolment may be reimbursed solely if the course is not activated.

In that case, the student may submit to the Master Director a request for reimbursement.

Sitting-in students must pay a fee of  $\in$  1,000 for each module they wish to attend; an amount of  $\in$  700,00 must be added to the fee as a fixed university tax. Both amounts must be paid in one installment by the date fixed by the Master Director. Students sitting in on lessons do not pay the selection fee.

# 9 - Scholarships

If the Master receives financial contributions from sponsors, they will be assigned, to partially or totally cover the registration fee, by taking into account the admission list of merit.

In the event of complete financing of the enrolment fees, the sponsors are required to pay the entire amount in one installment no later than the deadline for the second installment of the enrolment fees. If the student has a personalized sponsor, and/or employer with the duty to finance the enrolment fees on behalf of the student, such procedure must be authorized ahead of time by the Master's Director; the payment will need to be made in one installment no later than the deadline for the second installment of the enrolment fees. If payment is made after the deadline the student will be

# 10 - Late payment of the registration fee

Students paying the registration fee are regularly registered and covered by insurance.

required to pay a fine for late payment as described in section 10.

If a student does not pay the first installment within the deadline, he/she is considered <u>dropped out</u>. Late registrations may be accepted only if authorized by the Master Director and only after scrolling the list. In case of non-compliance with a payment deadline, an extra-fee of  $\epsilon$  62 (for delayed payment) must be paid for each late installment. If the delay overcomes <u>60 days</u>, the extra-fee for late payment is  $\epsilon$  124 for each late installment.

The form including the **late payment fee** will be prepared by the Master Office once the late payment has been authorized by the Master Director.

The last-year student and those admitted with reservation will pay the Master fees without fines after their graduation.

# 11 - Moving to another Master

Transfer from one Master course to another is not allowed.

#### 12 - Renunciation

Admitted participants who would like to withdraw from the course must inform in writing the Master Director. The EuroSapienza Secretariat will send this information to the Master Office. The registration fees already paid by dropped out students are not refundable.

#### 13 - Tax for the final exam of the Master

Before the final exam, participants are required to pay a graduation fee of € 70. The related form may be downloaded from the website <a href="www.uniroma1.it/studenti/infostud">www.uniroma1.it/studenti/infostud</a>, by inserting the matriculation number and password and selecting in order: - TASSE - DIRITTI DI SEGRETERIA - tipo di bollettino: select the option "Esame finale Master" - choose year 2014 - insert the course code: 14382 - AVANTI - STAMPA.

Note that the emission date printed on the paying-in slip has an emission date which is equal to the expiry date. A student who has not passed the Master final exam and would like to register for another course for the following academic year, must pay the tax for the final exam before the matriculation with the new course.

#### 14 - AlmaLaurea Questionnaire

Students must register through **Registration** (step 1), insert **username and password** in the LOGIN section (step 2), fill in, print the document (step 3), and deliver it to the EuroSapienza Secretariat.

#### 15 – Obtaining the Degree

At the end of the Master course, to obtain the Master degree, students must pass a final exam consisting in the preparation and discussion of a Project work.

To be admitted to the final exam the students must have:

- attended the Master activities,
- received the necessary credits for the master formative activities,
- paid the registration fees and the tax for the final exam,
- filled in the AlmaLaurea questionnaire,
- printed the related document to be delivered to the EuroSapienza Secretariat.

The final Project work must be presented and defended in front of a Committee which will give its evaluation on a scale up to 110 (one hundred and ten). The minimum grade to get the Master Diploma is 66/110 (sixty-six). The Committee may unanimously add honors (lode) to the maximum grade 110. The Master Diploma is issued by the Sapienza University of Rome only after a check of the regularity of the career and administrative position of the student.

The final Master Poster does not report the grade, except if it was achieved with honors.

It will be handed out to the graduated students by the Master Director.
