- The European Charter for Researchers and the Code of Conduct constitute a set of general principles and requirements specifying the role, responsibilities and rights of researchers and of organisations that recruit and/or fund researchers.
- The Charter aims to ensure that the nature of the relationship between researchers and employers or funders fosters the production, transfer, sharing and dissemination of knowledge and technological development and is conducive to the professional development of researchers.
- The '**HR Strategy for Researchers**' is an initiative from the European Commission to implement the rules and principles of the European Charter for Researchers and the Code of Conduct for the Recruitment of Researchers.

- The European Commission recognizes with the "**HR Excellence in Research Award**" institutions that make progress in aligning their human resources policies with the 40 principles of the Charter & Code, based on a personalized action plan/strategy for human resources.
- Sapienza obtained, on 11/16/2020, the "HR Excellence in Research" recognition
- Some numbers:
 - 701 organizations have received the HR Excellence in Research award.
 - In Italy: 19 organisations



- On 16/11/2020, Sapienza received the "HR Excellence in Research" award, assigned by the European Commission as part of the "Human Resources Strategy for Researchers – HRS4R" initiative.
- The prestigious Award was awarded for the constant commitment to improving policies in favor of the implementation of the principles of the European Charter for Researchers and the Code of Conduct for the Recruitment of Researchers, with particular attention to 4 thematic areas:
 - ethical and professional aspects;
 - open, transparent and merit-based recruitment policies;
 - working conditions and social security;
 - training and career development:




